# Heterozygous (Hybrid) definition

Your genes are made of DNA. This DNA provides instructions, which determines traits like your hair color and blood type.

There are different versions of genes. Each version is called an allele. For every gene, you inherit two alleles: one from your biological father and one from your biological mother. Together, these alleles are called a genotype.

If the two versions are different, you have a heterozygous genotype for that gene. For example, being heterozygous for hair color could mean you have one allele for red hair and one allele for brown hair.

The relationship between the two alleles affects which traits are expressed. It also determines what characteristics you're a carrier for.

Let's explore what it means to be heterozygous and the role it plays in your genetic makeup.

Difference between heterozygous and homozygous

A homozygous genotype is the opposite of a heterozygous genotype.

If you're homozygous for a particular gene, you inherited two of the same alleles. It means your biological parents contributed identical variants.

In this scenario, you may have two normal alleles or two mutated alleles. Mutated alleles can result in a disease and will be discussed later. This also affects which characteristics appear.

### Rh Negative blood type hypersensitivities

Certain drugs bind to particular cells and become immunogenic in some people, provoking the synthesis of antibodies and the destruction of the cells to which the drugs are attached. People with Rh neg blood are hyper sensitive to immunizations because they don't have the The Rh antigen called the **D** antigen responsible for creating antibodies (Human anti-D antibody is given to prevent this problem (RhoGAM shot which can cause problems of the immune system in mother & child). Rh-negative people don't naturally have anti-D antibodies, but they quickly develop them if they become immunized. There are two ways that Rh-negative people become immunized with D (+) RBCs: 1. Rh-negative woman pregnant with an

Rh-positive child. The child's RBCs leak into the mother particularly during childbirth. This immunizes the mother and subsequent pregnancies are at risk because the anti-D antibodies easily cross the placenta. These destroy the red cells of the developing fetus and the newborn. Hence the name: erythroblastosis fetalis or hemolytic disease of the newborn. Human anti-D antibody shot is given to prevent this problem. How might this work? 2. #### Rh- worse over-all Health

Since Rh- (Rh-negative) is an allele which is found predominantly among white populations (ca. 40-45% in Europe), it must clearly be a mutation which followed after man's migrations from Africa to Europe (**Or by mixing with the Anunas**). Moreover, Rh-negative is found much more frequently among A and O blood groups, which are the major blood types in Western Europe, whereas Rh-negative is much rarer among persons with B and AB blood types.

Rhesus-positive and Rhesus-negative persons differ in the presence-absence of highly immunogenic RhD protein on the erythrocyte membrane. The biological function of the RhD molecule is unknown. Its structure suggests that the molecular complex with RhD protein transports NH3 (Ammonia) or CO2 (carbon dioxide) molecules across the erythrocyte cell membrane.

"Rh proteins act as gas channels that help speed the transfer of (CO2) in and out of red blood cells. CO2 can also pass through the cell membrane unaided (above right), but not quickly enough."

Hence, it would seem to be a likely hypothesis, that Rh- (Rh-negative) developed due to a (presumably beneficial) change mandated in our human breathing of the Earth's air in the more northerly European latitudes (**Or that the Rh Negative blood came from a different planet with less CO2 in its atmosphere??**)

Some data indicate that RhD positive and RhD negative subjects differ in their tolerance to certain biological factors, including, *Toxoplasma* infection, aging and fatigue. Present cross sectional study performed on 3,130 subjects) showed that Rhesus negative subjects differed in many indices of their health status, including incidences of many disorders. Rhesus negative subjects reported to have more frequent allergic, digestive, heart, hematological, immunity, mental health, and neurological problems. There are various speculations as to where the term "blue blood" origins and again: This is not based on science.

What is however true is that there are very small amounts of copper in everyone's human blood. And that is equally in both: rh negatives and rh positives. Normally most of the copper in your blood is carried by a protein called ceruloplasmin.

Adults have 50 and 80 milligrams (mg) of copper in their body, mostly in muscle and the liver. Copper helps make melanin, bone, and connective tissue. It also helps with many other processes in your body. You normally get copper through your diet, in foods like liver and other organ meats, seafood, beans, and whole grains. You get rid of copper in your bowel movements and urine.

Various health problems can disrupt normal copper levels. This can cause you to have too little copper (copper deficiency) or too much copper (copper toxicity).

The O, A, B and AB types have different types of Antingens or immunity. This would be the same for the two RhD factors, Positive (immunity is present) and Negative (immunity is absent.)

The blood type O is recessive, that means that if a person with type O blood mates with an A or B blood, the children will become A and B and could not be type O.

Each male and female carry two alleles, one inherited from each parent. There are people with two negative or two positive or one positive and one negative alleles.

Therefore, the male of the Royal race carrying the pure RhD negative blood (two negative alleles) could impregnate an RhD positive females easily. The children of these women would have hybrid blood (one negative allele from the male of the royal race and one positive allele from herself.) They would be considered 1/2 bloods or demigods ("demi" means half.) Two half blood male and female could have a pure blood RhD negative child.

According to the Sumerian cuneiform tablets Enki mated with two female Earthlings and from their hybrid daughters and Enki's seed again, the first set of half bloods were called Adapa and Titi. Known as the Adam and Eve of the Bible who tended the garden of Eden (Edin) in Enki's domain.

### RH Negative Blood Type

"Rhesus factor is a part of your blood type. It's the Positive "+" or Negative "-" in A+, B-, O+, etc. Rh factor is a blood type from the Rhesus blood group. Just like A is a blood type from A B O blood group.

Where did Rhesus factor come from?

**Humans DID NOT get the Rhesus from any monkey!** Scientists just happened to first discover the Rh + (Rhesus) Positive blood type in Rhesus monkeys and named it after the macaque monkey.

Some forms of Rhesus molecules are found in MOST life form on Earth, ranging from algae to fish to humans. Rhesus factor descended from a molecule called Amt. Amt is found in every living thing, even in Archaea, which is possibly the most ancient life form on Earth.

All animals and other living creatures known to man can breed with any other of their species. Why does infant's haemolytic disease occur in humans if all humans are the same species?

Haemolytic disease is the allergic reaction that occurs when an Rh negative mother is carrying a Rh positive child. The mother's blood builds up antibodies to destroy an ALIEN substance (the same way it would a bacteria/virus), thereby destroying the infant. Why would a mother's body reject her own offspring?

Nowhere else in nature does this occur naturally. This same problem does occur in mules - a cross between a horse and donkey. This fact alone points to the distinct possibility of a cross-breeding between two similar but genetically different species. Scientists don't knows where the Rh negative people came from.

Rhesus negative blood simply means that the blood doesn't have any Rhesus antigens on the surface of the red blood cells. As for why there are so few people with Rh negative blood, Rh-negative is a recessive trait, so all an individual needs is one functional Rhesus gene to produce Rh positive blood.

Since Rh negative blood does not hinder an individual's survivability or confer any evolutionary disadvantage other than the inability to receive Rh positive blood (which is pretty much a non-factor during the time period when blood transfusions weren't available), people with non-functional Rhesus genes continued to thrive and reproduce which is why there are still individuals with Rh negative blood.

Most, familiar with blood factors, admit that these people must at least be a mutation if not descendants of a different ancestor or species.

The Basque people of Spain and France have the highest percentage of Rh negative blood. About 30% have 2 (rr) Rh negative alleles and about 60% carry one (r) negative gene. The Oriental Jews of Israel, also have a high percent Rh negative, although most other Oriental people have only about 1% Rh negative. The Samaritans and the Black Cochin Jew also have a high percentage of Rh negative blood, although again the Rh negative blood is rare among most black people. The Rh Negatives Factor is considered a "Mutation" of "Unknown Origin", which happened in Europe, about 25,000 years ago and inhabited the Pyrenees Mountains,. Then this group spread heavily into the area of what is now Spain, England, Ireland, etc (Catalonia's ancient traditions state Tubal-Cain, grandson of Noah, son of Japheth, migrated to Iberia and founded Tarragona in Catalunya, about two hundred years after the Great Flood (circa 5700 years ago).

In 2021 5% of the Earth's population are currently Rh-Negatives.

#### Blood types and Rh factor by country

Typically when blood is drawn at an early prenatal visit, your blood will be tested to determine both blood type and Rh factor. If you don't know your type, ask your doctor/midwife. The most common blood types are A+ or O+.

Below is a chart showing blood types (A, B, AB, O) and Rh Rhesus status (Rhpositive and Rh-negative) by country. Over 92% of all people are Rh-positive and the rest are Rh-negative.

But, they are 15% of the population of the England and the USA. The most distinctive members of the European branch of the human tree are the Basques of France and Spain. They show unusual patterns for several genes, including the highest rate of the Rh-negative blood type. Their language is of unknown origin and cannot be placed within any standard classification.

Consider Iceland, 1% of its population is Rh-negative. The population of Iceland is about two-third of Scandinavian and one-third of Irish descent. Scandinavia, Ireland, and the British Isles show from 16% to 25% and above Rh-negative. The other populations with a proportion of Rh-negative individuals similar to Iceland occupy the eastern half of Asia, Madagascar, Australia and New-Zealand. The people of the Basque region have a greater than 50 percent concentration of the RH negative gene. The frequency decreases in relation to the distance from the Basque region into the rest of the world until there is very little evidence of this gene. Science tells us that the red hair DNA did not originate with human beings but was Neanderthal DNA. It is interesting that Neanderthals have a high O frequency, because the other group with a high O frequency today is native Americans (the original Earthlings?).

"When we look at the Y-chromosomes in Wales and Ireland, we find a very close match with the Basques."

"Other genetic evidence, he says, strongly suggests that the Basques are the descendants of the Paleolithic inhabitants of Western Europe prior to the arrival of farmers between 9,000 and 6,000 years ago".

We also know that the 10 Lost Tribes of Israel known as the Hebrews migrated into Europe and became a blended group who would later become known as the Scythian, aka Aryan (Noble) Races.

During a period in history known as the Dark Ages, which happened around 1200 - 800 B.C. they migrated into Europe from the Caucasus and Carpathian mountain ranges while the "Tribe of Dan" was shipped into Western Europe with the aid of the Phoenicians from the Mediterranean Sea at about the same time in history. ### Stan Gooch & the Neanderthal Legacy

Gooch gave up his secure position, turning down both the directorship of the National Children's Bureau, and a professorship of Psychology at Brunel University, London, to pursue his research and writing that the Neanderthals developed in time a culture of the mind of a very high order, but also of a strangeness that is extremely difficult for us to imagine. Neanderthals, according to Gooch, worshipped the cave bear, the spider, and the serpent – animals with whom they shared their caves. Neanderthals were the first humans to fully develop religious cults, and cave bear worship was their most significant cult. Neanderthals worshipped the number 13, associated with the moon and the lunar calendar, a number that is still considered magical today. Neanderthals developed a profound knowledge of crystals and minerals. According to Gooch, Neanderthals developed their own unique symbols, signs, and sophisticated language systems. 17 Neanderthals weaved and sewed embroidery, wore jewellery, painted their faces and bodies, danced, had an elaborate, mythology and cosmology, built stone circles, utilized sacred fires, and made ceremonial sacrifices. They had their own grand celebrations and feasts, which were spectacularly colourful and creative performances.

They worshipped the moon and other celestial bodies including constellations still worshipped today worldwide such as The Big Bear, Little Bear, and Draco (the dragon or serpent in the sky). Gooch asserted that Neanderthals had a strong religious life, based on an earth-magic religion, and they believed in the afterlife, practicing complex burial rituals. 18

The structure and nature of Cro-Magnon life was diametrically opposite. This was a patriarchal, hunter-warrior society, of which men governed all aspects, including religious life. Women were mere adjuncts in all things, whose main purpose was to bear sons and to comfort and care for the male. The supreme deity worshipped was the sun god. 23 (His research supports the theory that the Neanderthals are the Anunas)

11. HISTORY & CHARACTERISTICS OF THE GODS

The information derived from ancient texts found in thousands of clay tablets from ancient Summer, was the work of Noah Kramer. The Sumerian rulers and high priest claimed to be the descendants of the tribe of AN (known as Anuna or Anunas) and kinship with the people of Dilmun. Dilmun was described in the saga of Enki and Ninhursag as pre-flood paradisiacal place, where predators don't kill, pain and diseases are absent and people don't get old. Dilmun was an important trading centre. At the height of its power, it controlled the Persian Gulf trading routes. Genetic studies of the

Sumerian, Berbers, the Basque population can help determine their origin. Their large eye socket size and blue colour, which research supports my timeline of the arrival of the "royal race of gods" to Earth: In 2008 research from the University of Copenhagen show that people with **BLUE EYES** have a single, common ancestor. Scientists, whose research is published in the journal of human Genetics, identified a single "mutation" in a **gene called the OCA2**, which appeared by "unexplained chance" somewhere around the northwest coasts of the Black Sea in one single individual, about 8,000 years ago and is the cause of the eye colour of all blue-eyed humans alive on the planet today: "Originally, we all had brown eyes," said Professor Hans Eiberg from the Department of Cellular and Molecular Medicine. Variation in the colour of the eyes from brown to green can all be explained by the amount of melanin in the iris, but blue-eyed individuals only have a small degree of variation in the amount of melanin in their eyes. From this we can conclude that all blue-eyed individuals are linked to the same ancestor," says Professor Eiberg. They have all inherited the same switch at exactly the same spot in their DNA.

In humans, there only exists **TWO** true eye colors in nature: brown eyes and blue eyes. This is proven through true detoxification. Green eyes are blue eyes that either have sulphur/drug deposits (from antibiotics, preservatives & foods) appearing as a yellow color - making the eye appear green, or they have an eye of subacute lymphatic congestion (which also appears as yellow in an iris). Antibiotics cause chronic congestion of the lymph (lymphs remove toxins from the bloodstream). Those with hazel eyes are also true-blue eyed people - with chronic congestion of lymph on top of their blue color. # The Dragon Blood Royal Dynasties

Paternal - Maternal Descent: The DNA Bridge

Paternal and Mitochondrial Dragon DNA explains the importance of the female decent.

Mitochondrial DNA is passed only through the female line. Mitochondria is a living sentient and separate life form from ourselves. The mitochondria are dependent on us for life; we live in a symbiotic relationship.

Mitochondrial DNA can live 15 generations. 15 generations of living mitochondria live inside you. Your 15 generation grandparents living cells are in you. A mutant mtDNA will drift to fixation in a human matrilineal in 15 generations.

Recently an attempt was made to estimate the age of the human race using mitochondrial DNA.

This material is inherited always from mother to children only.

By measuring the difference in mitochondrial DNA among many individuals, the age of the common maternal ancestor of humanity was estimated at about 200,000 years.

It remains implausible to explain the known geographic distribution of mtDNA sequence variation by human migration that occurred only in the last 6,500 years.

Mitochondrial DNA (mtDNA) by virtue of its maternal, non recombining mode of inheritance, rapid pace of evolution, and extensive intra-specific polymorphism; jipermits and even demands an extension of phylogenetic thinking to the microevolutionary level. Many species exhibit a deep and geographically structured mtDNA phylogenetic history.

Study of the relationship between genealogy and geography constitutes a discipline that can be termed intraspecific phylogeography (linages by geography), 'alien genes' in human DNA.

The (Central Asian) Khazar name is derived from Turkic \*qaz-, meaning "to wander." The Ashina was considered a sacred clan of quasi-divine status. Q1 actually refers to the subclade Q-P36.2.

The Ashina clan, a noble caste, carry the 16q24.3 "red gene" inherited from the Sumerian Anunas, the root of the Dragon seed that permeates royal lines:

Merovingian Carolingian Tudor Plantagenet Stuart Hapsburg Hanoverian Saxe-Coburg-Gotha Guelph Bowes-Lyon Battenberg (Mountbatten) Guise Savoy, ...families - and Transylvanian lineages.

The Davidic House of Judah married into the descent of the Merovingian Kings of the Franks. They are connected by a shared bloodline. The dragon archetype rests within the Dragon blood, passed on through the genes.

The re-expansion of paternal group R1b and maternal group H from the Basque Ice Age refuge, spread up the coasts of all the countries facing the Atlantic after the ice melted (Noah's flood c4000 BC per cometogrpahers & genealogies). The British Isles retained higher rates than the other countries, for several reasons related specifically to early movements directly from the Basque country rather than from general diffusion from western Europe.

### R1b and Q1 Blood Descent

First, as a result of lower sea levels, the British Isles, in particular Ireland, were connected and at the furthest edge of the extended Ice Age European continent, and thus received the bulk of early coastal migration.

Then, as sea levels rose, first Ireland then Britain became islands, relatively insulated from further migration from elsewhere in Europe, thus preserving their high rates of R1b and similarity to the initial settlements.

The means by which I could separate the R1b types in the British Isles from those on the other side of the channel is by the use of "Founder Analysis."

That is, looking at the detail of their gene types (so-called STR haplotypes). These revealed 21 founding clusters, which could only have arrived direct from the Basque country. Their descendant twigs are unique to the British Isles.

### Founding of the Royal Court

According to Nicholas de Vere: "Briefly, **the Dragon lineage starts in the Caucasus with the Anunas**, descending through migrating proto-Scythian to the Sumerians while branching off also into the early Egyptians, Phoenicians and Mittani. A marriage bridge back to Scythia infused the Elvin line of "Tuatha de Danaan" and the Fir Bolg, which branched

into the Arch-Druidic, Priest-Princely family to the Royal Picts of Scotland and the ring kings of the Horse Lords of Dal Riada, through the Elven dynasty of Pendragon and Avallon del Acqs, and down to a few pure bred families today."

The Royal Court of the Dragon was founded by the priests of Mendes in about 2,200 BC and was subsequently ratified by the 12th dynasty Queen Sobeknefru.

This sovereign and priestly Order passed from Egypt to the Kings of Jerusalem; to the Black Sea Princes of Scythia (Princess Milouziana of the Scythians) and into the Balkans - notably to the Royal House of Hungary, whose King Sigismund reconstituted the Court just 600 years ago. Sigismund's assumed descent from Melusine.

Her ancestry actually can be traced back to the Scythian Dragon Princess Scota, Queen Sobekh Nefru and the Egyptian Cult of the Dragon. **Vlad Dracul** the impaler, was a minion of Sigismund of Luxembourg, and was educated at the Emperor's court in Nuremberg. Dracul was invested into Societas Draconis.

The Byzantine Emperor Constantine was a Dragon King. The Byzantine emperor Leo III married his son Constantine (V) to the Khazar princess as part of the alliance between the two empires.

Princess Tzitzak was baptized as Irene. Their son Leo (Leo IV) was known as "Leo the Khazar", emperor of the Eastern Roman (Byzantine) Empire from 775 to 780.

These celestial creatures have been variously identified with Dragons, Elves, Fairies, Gnomes, Leprechauns, Sprites, Nymphs, Pixies, Angels, Demons, Devils, Witches, Giants, Vampires, Werewolves, and just about every mythical being you can imagine.

Some, like Gardner and Sitchin, claim that they come from another planet. Others, like de Vere, say that they're multi-dimensional, or that they're from the Hollow Earth." "The Biological Basis of Elitism and Divine Right Rule"

Sir Laurence is also a Presidential Attaché to the European Council of Princes (a constitutional advisory body established in 1946), and Chancellor of the Imperial and Royal Court of the Dragon Sovereignty.

He is formally attached to the Noble Household Guard of the Royal House of Stuart, founded at St Germain-en-Laye in 1692, is the Jacobite Historiographer Royal by Appointment, and is a Fellow of the Society of Antiquaries of Scotland. He was involved with a number of organizations - the Celtic Church being one in particular, for which I'm the Grand Prior in Britain [that is, the Celtic Church of the Sacred Kindred of St Columba].

He was appointed as a Presidential Attaché to an organization called The European Council of Princes.

The Council was founded in 1946, directly after the War, and the object was fairly straightforward. (In fact, some of the financing actually came from this country [Australia], and a lot from America as well). It was at a time when there was a tremendous fear about the build-up of further extremist right-wing factions, and there was also the fear that the communist left-wing might take a hold in Europe. It was decided, therefore, to set up a watchdog committee called The International Council of Government, whose brief was to keep an eye on the extreme political factions.

About ten tears ago, the Council changed its name to become The European Council of Princes.

With the eventual establishment of the European Parliament, an advisory body consisting of thirty-three European royal houses. These might be reigning houses, dispossessed houses or deposed houses. Its President since 1992 has been HRH Prince Michael of Albany, the current heir to the Royal House of Stuart - the House that was deposed in Britain from 1688. The House of Stuart, having taken over the presidency of the Council from the House of Habsburg-Austria, related it to its one-time Royal Academy, which was a very scientific establishment. In fact, in the 1700s in particular, it was highly **Rosicrucian** - very scientific and alchemical. From the time of Robert the Bruce, the Chancellor of that organization was given the title **Prince Saint Germain**. This title had little to do with the 5th-century saint himself (except indirectly), but it had to do ultimately with the Stuart Royal Court in France, at the Palace of Saint Germain.

The Chancellor title was changed in the 1700s to Count Saint Germain, and in the 1890s it was changed again to become Chevalier Saint Germain. Gadners' knighthood is a Franco-Scot distinction attached to the Stuart Royal Court of France [as ratified by King Louis XIV in 1692], in the key Noble Order of the Royal Palace of Saint Germain-en-Laye, near Paris. Gardner was made a Fellow of the Society of Antiquaries of Scotland.

In his books he covers 6,000 years of Messianic inheritance from the time of Adam, through King David and Jesus, down to the present day, compiling this genealogical descent and its fascinating history. Bloodline of the Holy Grail covers a historical period from the time of Jesus through the past 2,000 years. Subsequently, Genesis of the Grail Kings was written to answer the most asked questions: Why was the Grail Bloodline so important in the first place? Why was the kingly line which descended to Jesus and beyond so unique from the outset in old Mesopotamian times?

The Messianic succession of Grail dynasts (or Dragon Kings) was alchemically conceived and purposebred for the role of earthly leadership (the alchemical marriage was the combination of the King's Y-Chromosome with the queen's mtDNA). We looked at the records of ancient Sumer, which talked of the Anunnaki gods and their "creation chamber".

We saw how the great vulcans of the era produced the enigmatic Highward Fire-stone (the white powder of monatomic gold) that was used to feed the Light-bodies of the Babylonian Kings and Egyptian Pharaohs. And we saw how this substance, when ingested, had stunning effects on the body's endocrine system. Ultimately, we followed the senior line of royal descent (a line that was genetically determined by the mitochondrial DNA of the Dragon Queens) down to the time of Moses. In ancient Mesopotamia, kings of the Grail bloodline were supplementally fed with the lunar essence or menstrual extract of the matrilineal Anuna Dragon Queens, which became known as Star Fire. This was said to be 'nectar of supreme excellence' since it carries the mtDNA essential elements & DMT, which heightened the recipients perception & awareness. These queens were likened to lilies or lotus flowers, with names such as Lily, Lilith, Luluwa, LilUtu & Lillet. From this tradition originates the family name du Lac as in Lancelot of the Lake prominent in Arthurian lore, which means Lancelot of the Dragon blood. Rosi-crucis cup emblem of the Holy Grail was identified with the Messianic blood, held within the sacred chalice of the maternal womb.

Now we shall take a look at the wider scheme of things, in terms of the folklore and fable which have emanated from the alchemical realm of the Pendragons. And we shall consider, in particular, **the longstanding disputes which have prevailed between the sacred Bloodline and the Church establishment.** Popular legends like Cinderella, Robin Hood, Sleeping Beauty or Count Dracula are rooted in the culture of the Grail Kings.

Even though some of the themes have their origins in very old lore, the majority of tales (as we know them) were newly slanted from the Dark Ages onwards, and especially from mediaeval times when the Church's persecution of Grail heretics was in full swing, leading to the Catholic Inquisitions.

Among the best known of these heterodox Christians (or "heretics") in the Middle Ages were the Cathars, the Pure Ones of the Languedoc region in southern France.

And they, in line with the Dragon tradition of the Ouroboros Ring Lords, referred to the Messianic Bloodline as the Elven Race. As we shall see, the terms "elf", "fairy", "pixie" and the like were all representative of various castes within the kingly succession.

The Ouroboros (as detailed in Genesis of the Grail Kings) was a symbol of wholeness, unity and eternity, usually identified by a serpent (in the form of a ring) clutching its own tail. With a cross positioned beneath the ring, the emblem becomes the familiar device of the female - the Venus symbol.

Alternatively, with a cross positioned above the ring, it becomes the masculine Orb of sovereign regalia. And with the cross positioned within the ring, it becomes emblematic of the Holy Grail itself - identified as the Dew Cup, or the Rosi-crucis. In the Cathar language of old Provence, a female elf was an albi (elbe or ylbi), and Albi was the name given to the main Cathar centre in Languedoc. This was in reference to the matrilineal heritage of the Grail dynasty, for the Cathars were supporters of the original Albi-gens - the Elven Bloodline which had descended through the Dragon Queens of yore, such as Lilith, Miriam, Bathsheba and Mary Magdalene.

It was for this reason that, when Simon de Montfort and the armies of Pope Innocent III descended upon the region in 1209, it was called the Albigensian Crusade. Through some 35 years, tens of thousands of innocent people were slaughtered in this brutal campaign - all because the inhabitants of the region were champions of the original concept of Grail kingship, as against the pseudo-style of monarchy which had been implemented by the papal machine.

In practical terms, Church kingship prevailed from the 8th century and it has continued through the ages to the present day. But the fact is that, under the strict terms of sovereign practice, all such monarchies and their affiliated governments have been illegitimate.

So, what is Church kingship? It applies to all monarchs who achieve their regnal positions as a result of Church coronation by the Pope, or, in Britain, by the Archbishop of Canterbury. In terms of true kingship, there is no necessity for coronation because kingly and queenly inheritance are, and always were, "in the blood" - to be precise, in the mitochondrial DNA of the Sangréal.

In the old scheme of things, kingship was automatic because it was an alchemical inheritance which, in practice, had nothing to do with ruling over anyone or anywhere. By virtue of an illegal dictate, however, monarchies were brought under Church control and the magical Realm of the Ring Lords was supplanted by the material and territorial reigns of the papal kings.

Because the **Cathars, the Knights Templars, the Rosicrucians, some gnosti**c groups and fraternities stood up for the legacy of the Holy Grail, it led to the hideous **tortures and executions of the papal Inquisitions and witch-hunts** that persisted through so many generations.

By the Middle Ages, the Church controlled the majority of European monarchies (with Scotland a notable exception, as a result of which King Robert the Bruce and the whole Scottish nation were excommunicated). The Church, therefore, influenced governments, parliaments and educational establishments (as it still does today). And, by implication if not by direct instruction, the military forces of the pseudo-kings operated at Church command.

The Church held such enormous financial, political and military power that the Grail adherents became an "underground stream", living in fear of their lives at every turn.

They were not only heretics: they were singled out for punishment as sorcerers and necromancers (they worshipped the head of John the Baptists). And since they did not conform to papal dictates, they were clearly Satanists! The women, of course, were all whores, but this was nothing new; the Roman Church had forged this dogmatic classification at the time of its earliest constitution!

All monarchical and governmental practice has, for centuries, been based upon the initial precept of "The Donation of Constantine" however, the precept is wholly invalid & many of the dynasties which have actually reigned have done so with little or no sovereign heritage. They have gained their positions simply because it suited the Church to crown them as its puppet representatives.

Moving forwards in history from the Pharaohs of Egypt, the Davidic Kings of Judah and the Dragon Kings of Scythia, we arrive in the Dark Ages with the Celtic kingdoms of Europe and, essentially for the purposes of this story, with the Fisher Kings in Gaul (which later became France).

As detailed in Bloodline of the Holy Grail, the Church of Rome (founded by Emperor Constantine the Great in the 4th century) had little to do with the Nazarene style of Christianity which it officially superseded and had hitherto persecuted. It was an entirely new, hybrid form of male-dominated "churchianity" based upon a contrived apostolic succession of popes. The separate Nazarene movement (often called the Celtic Church) continued in opposition under the direction of Grail dynasts from the family of Jesus, and they were styled the Desposyni, meaning Heirs of the Lord.

At that time, the Bloodline houses of the Desposyni held the reins of Dragon kingship in Europe. But the bishops of the Roman Church sought to undermine this tradition, and eventually managed this in the 8th century (after planetary catastrophes & a possible pole shift) when they deposed the Merovingian Fisher Kings of the Franks after some 300 years of regnal succession.

With the sudden, contrived demise of this Grail dynasty in 751, a new style of kingship was introduced in the West - kingship not by any right of succession, but by individual decree of the Pope. The Donation made its first appearance in the middle 8th century, it was alleged to have been written by Emperor Constantine 400 years earlier, it was even dated and carried his supposed signature. What the document proclaimed was that the Pope was Christ's elected representative on Earth, with the power to "create" kings as his subordinates. The provisions were put into

operation by the Vatican in 751 and a whole new dynasty was supplemented by a family who had been mayors of the Royal Palace (the equivalent of prime ministers). They were dubbed "Carolingians", and their only king of any consequence (through some 236 years) was the legendary Charlemagne.

As a result of this strategy, the whole nature of monarchy changed from being an office of "guardianship" to one of "rule". Henceforth, the papal monarchs were territorial governors rather than patriarchs of the people. By virtue of this monumental change, the longstanding Grail Code of princely service was forsaken and European kings became servants of the Church - which had the power to make them or break them.

The monarchs of the Grail succession were called Messiahs (Anointed Ones) because, in the early days in Mesopotamia and Egypt, they were anointed with the fat of the sacred Messeh (the holy dragon or crocodile) they were also called Dragons. The Dragon, emblematic of wisdom, was the epitome of the Holy Spirit which, according to the Book of Genesis, moved upon the waters of time (plasma tails of planets & symbol of Enki), while the Grail was the perpetual Blood Royal - the Sangréal. Originally, in old Mesopotamia, it was called the Gra-al - the Sacred Blood of the Dragon Queens - and their menstrual blood was said to be the "nectar of supreme excellence". The ancient Greeks called it ambrosia (Barbara Marciniak an alleged chaneler of the Pleiadians says the same thing in Bringer's of the Dawn).

The concept of **fairies** (the fair folk) was born directly from this base, being a derivative of "fey" and relating especially to "fate". In the Celtic world, certain royal families (especially those of the Pendragons, or Head Dragons) were said to carry the Fairy Blood - that is to say, the fate or destiny of the Grail Bloodline - while the Elf Maidens of the Albi-gens were the designated guardians of the Earth, starlight and forest.

The Church enveloped within a shroud of supernatural enigma & fantasy the dragons, fairies and elves of history. **Adolf Hitler's** fanatical obsession with finding the Hallows of Grail Castle where he obtained an ancient lance (said to have been used by Charlemagne) which he insisted was the Longinus spear that pierced the side of Jesus at the Crucifixion. This, he reckoned, was the sacred Spear of Destiny, so revered in Grail lore. With this in his possession, Hitler was confident that his empire would be as strong as that of Charlemagne.

The Tarot is full of Rosicrucian symbology. These Hallows were represented in the four suits of the Tarot's Minor Arcana as the Swords, Cups, Pentacles and Wands - subsequently to become the Spades, Hearts, Diamonds and Clubs that we know today.

Throughout the best part of this millennium, no organization has misused the Grail Chalice symbolism to greater effect than the Christian Church establishment. From the earliest times, the Rosi-crucis (the chalice and wine of the Grail sacrament) was a prerogative of the Albi-gens, being emblematic of the Blood Royal in the womb of the Dragon Queen.

In William Shakespeare's A Midsummer Night's Dream, the Queen of the Fairies is Titania, whose name represents the pre-Olympian god-race of the Titans. In particular, she is the Moon Goddess Diana. Their king, Oberon, however, had an historical base, being inspired by an ancestor of Shakespeare's colleague Edward de Vere, 17th Earl of Oxford. He was a founding member of Elizabeth Tudor's 16th-century Court Poetry and Magic Syndicate - along with Francis Bacon, John Dee, Edmund Spenser and others of the Rosicrucian "underground stream" who aided and guided much of Shakespeare's work.

Edward de Vere was, at that time, Lord Chancellor of England - as had been many generations of his forebears, including Albrey, the 12th-century Prince of Anjou and Guisnes, whose titular name, Albe-Righ, meant Elf King. What the Syndicate knew full well, despite their loyalty to Elizabeth, was that the House of Tudor had no prior right to the English throne, having simply taken it, by might of the sword, from the preceding House of Plantagenet.

That apart, the **Plantagenets** themselves were a junior branch of the House of Anjou, whose senior branch was the House of Vere. Their ancestry was jointly Pictish and Merovingian, descending from the ancient Grail House of Scythia. Here was a true kingly line of the **Elven Race**, and it was for this reason that Oberon (a variant of Aubrey/Albrey, the

historical Elf King) became Shakespeare's King of the Fairies. Some time earlier, in 1408, Edward de Vere's ancestor, Richard (Lord Chamberlain and 11th Earl of Oxford), had been invested as a Knight of the Garter by King Henry IV at Windsor Castle. Also invested at the same time was King Sigismund of Hungary, who had revived the ancient Egyptian Order of the Dragon - within which Richard de Vere held the hereditary distinction of **Lord Dragonis**.

One way or another, the nursery tales which emanated from the "underground stream" were stories of lost brides and usurped kingship - based upon the subjugation of the Grail Bloodline by the Church of Rome and, in later times, by the sectarian Puritans of the Protestant movement.

The Catholics had their Dominican Grand Inquisitor, Tomâs de Torquemada, and the Puritans had their equivalent in Matthew Hopkins, the Witchfinder-General.

Favored executions, in each case, were hanging, drowning or burning at the stake, and the common command was: "Kill them all - God will know his own!"

The fairy tale concept was essentially geared to stories relating to these persecutions: allegorical accounts of the predicament of the true Royal Family - the Ring Lords of the Sangréal, whose fairies and elves (having been maneuvered from the mortal plane of orthodoxy and status quo) were confined to a seemingly Otherworld existence.

In the course of their persecution, the Elf Maidens were pricked with bodkins, fed with poisoned apples or condemned to servitude - while their champions swam great lakes, battled through thickets and scaled mighty towers to secure and protect the matrilinear heritage of the Albi-gens. They include such well-known stories as Sleeping Beauty, Cinderella, Snow White and Rapunzel.

In all cases, the underlying theme is the same, with the Bloodline Princess kept (through drugging, imprisonment or some form of restraint) out of reach of the Grail Prince who has to find and release her in order to preserve the dynasty and perpetuate the line. For the most part, the establishment of the "Mother Church" was symbolized by a malevolent stepmother, an evil witch or some other jealous female with an opposing vested interest.

Always, the stories are reminiscent of the Lost Bride of the King in the Old Testament's Song of Solomon. Their content also embodies the forlorn aspect of **Mary Magdalene**, the bride of Jesus, whose royal heritage and maternal legacy were so thoroughly undermined by the Christian bishops.

An interesting feature of many classic fairy tales is that they truly are very old stories. Take Cinderella, for example. If asked who wrote Cinderella, many people would answer that it was the Brothers Grimm, while others would say it was Charles Perrault. However, these men were not actually writers of fairy tales, as is commonly thought. They were collectors, compilers and interpreters of the tales.

The composer Richard Wagner's personal association with Grail lore and, of course, his own famous Ring Cycle are well known.

Tolkien was quite accurate with his assessment of the original Ring Lords of the Albi-gens who, in the far distant years BC, were called the Lords of the Sidhé (pronounced "shee").

The Sidhé was a transcendent intellect, known to the Druids as the Web of the Wise, while "druid" (druidhe) was itself a Celtic word for "witch" - an English form of the Saxon verb wicca, meaning "to bend" or "to yield" (as indeed do willow and wicker).

The Tuatha Dé Danann (or Dragon Lords of Anu) were masters of the transcendent Sidhé, and were duly classified as "fates" or "fairies". Before settling in Ireland (from about 800 BC), they were the world's most noble race, alongside the early Kings of Egypt, being the Black Sea Princes of Scythia (now Ukraine). Like the original dynastic Pharaohs, they traced their descent from the great Pendragons of Mesopotamia; and from them sprang the kingly lines of the Irish Bruithnigh and the Picts of Scotland's Caledonia.

In Wales they founded the Royal House of Gwynedd, while in Cornwall in the southwest of England, they were the sacred gentry known as the **Pict-sidhé - from which derives the term "pixie"**.

So, from a single caste of the original Blood Royal - whether known as the Sangréal, the Albi-gens or the Ring Lords - we discover many of the descriptive terms which sit at the very heart of popular folklore. For here, in this one noble race, we have the "elves", "fairies" and "pixies" - not beguiling little folk, but distinguished Kings and Queens of the Dragon succession. In titular form, a Scythian Uper was an Overseer or, more importantly, an Overlord - the equivalent of a Pendragon.

Later, in the Hungarian and Romanian regions, the word gained the variant form, Oupire.

Until the mediaeval fabrications of the Christian Church, there was nothing remotely sinister or supernatural about the definition of Oupire, but this was eventually destined to change when the witch-hunts began, for the priestly/kingly Oupires were, in the eyes of Rome, the equivalent of Magian Druids.

They were therefore witches, and the Sidhé definition (Web of the Wise) the traditional Oupires had been apparent in the Balkan and Carpathian regions of Europe, having prevailed from Transylvania to the Black Sea in ancient times. They were said to be wandering people of the night, who consorted with evil spirits. At that stage, a new word was born into the language of Christian Europe. The word, a straightforward corruption of **Oupire**, was "vampire".

In addition to vampires, another classification was soon to enter the Inquisitional vocabulary as the Dominican Black Friars and the Franciscan Grey Friars compiled their lists of undesirables. They had now moved beyond the realm of ordinary heretics and pagans, for alongside their fabricated vampire myth they conjured another form of shape-shifting phenomenon: the werewolf.

Quite suddenly, there appeared to be no end to the fantastic creatures that were reckoned to stalk the streets and forests in search of unsuspecting victims. But the beauty of all this was that it had the effect of making people lean more heavily upon the Church - the only perceived route to salvation. These vampires and werewolves, it was said, could not be killed by conventional means.

Even God was out of the picture, for only the power of Jesus Christ (the Savior of humankind) could defeat these diabolical beings. They were portrayed as devils, demons and emissaries of Satan, who had to be exorcised and destroyed by the monks and clerics. And so the Church was in business with a whole new genre of scary folklore to counter the Grail Quest legends and esoteric artwork of the "underground stream".

On the one hand, there were the Albigensian tales of Swan Princes, Dragon Queens and Elf Maidens, comprising the lore of the forgotten Bloodline and the Lost Bride, wherein knights and chivalric champions battled against all odds to preserve the sacred heritage of the Holy Grail. In these stories, there were wizards of the Druidic school and wise hermits to guide the knights upon their journeys and missions.

But nowhere in these tales of enchantment did a gallant priest or bishop ever ride to the aid of a damsel in distress, for the Church was, in practice, the adversary.

What the bishops did, however, at the 1545 Council of Trento in northern Italy, was they formally blacklisted and outlawed the prophecies of Merlin, withdrawing all related material from the public domain.

With regard to the werewolves, who were said to manifest at the height of the full moon, the definition of were is, quite simply, "man" (hence, "werewolf" is "man-wolf"), but it comes rather more precisely from an ancient High Druidic caste of

Wood Lords (called Weres or Wallans). Their totem animal was the wolf - just as other tribes were represented by, say, a boar or a horse. These totems were really no more than the early predecessors of heraldry, whereby families became identified by the animals, plants, shells and other devices on their banners.

Historically, the Wallans became very influential, founding great kingly dynasties in Ireland, Wales and England. The great Cadwallan of Wales was of this Druidic race, as was King Casswallan, the intrepid son of Beli Mawr - the greatest of all the sovereign Wood Lords in about 100 BC.

Other totems, of course, were the various god and goddess representations, and it is especially relevant that one of these still holds a prime British national position today, having persisted though the centuries from the early culture of the Wood Lords.

The original Wallans were apparent in Mesopotamia around 3,800 years ago, in about 1800 BC. They were called the Yulannu, which meant, quite simply, Wood Lords. Indeed, it was from their culture that the original **Yule tradition** derived, subsequently making its way across Europe to Scandinavia.

The **venerated Goddess of the Yulannu was Barat An-n**a (Great Mother of the Fire-stone). The Sumerians called her Antu. She was the wife of the god Anu, and the mother of Enki. In later times, she was identified with Diana of Ephesus (Diana of the Nine Fires).

The cult of Barat An-na spread across Syria into the Phoenician kingdom, where they began to portray her on their coins. In these representations, she sat by the seashore with a torch of fire, and at her side was a round shield bearing the cross of the Rosi-crucis.

Along with the Wallan Druids, the culture of Barat An-na was brought to the British islands, where her name became compacted to Bratanna. And in those islands, her image persisted to the extent that she became the great tribal goddess - a goddess who, despite all the emergent centuries of Christianity, has prevailed to this very day.

Her image on the coins has barely altered, except that her flaming torch became a lighthouse, and the Rosi-crucis cross of her shield was amended to become the Union Jack. But, after all this time, she is still the Mother Goddess of the land, the Lady of the Fire-stone: Britannia.

The Cassi tribes were also from Mesopotamia, prior to which (having previously settled in the northern Zargos Mountains along with the Yulannu) they were Carpathian princes of the Sidhé. They were, in fact, of the Tuatha Dé Danann Fairy strain. They reigned in regional Mesopotamia from the 18th century BC and, from about 1600 BC, they governed all Babylonia for another 500 years.

These shrines ("fairy rings") were called the Creachaire (stone calendars & survival bunkers), and they housed the Raths which were turf-covered mound dwellings constructed upon a framework of poles.

One of history's best known Grail Fairies was Princess Melusine, daughter of the Pictish King, Elinas of Alba - a descendant of the 2nd-century King Vere of Caledonia, Lord of the Dragon. In the year 733, Melusine (maintaining the family heritage) married Rainfroi de Vere, Prince of Anjou, and among their offspring was Count Maelo, the commander of Emperor Charlemagne's army.

From Maelo's own marriage to Charlemagne's sister sprang the Vere Counts of Guisnes who, as previously mentioned, were the reputed Elf Kings and became England's Great Chamberlains and Earls of Oxford.

In the **Arthurian and Magdalene traditions** of the Ladies of the Lake, Melusine was a "fountain fey" - an enchantress of the Underwood. Her fountain at Verrières en Forez was called Lusina (meaning "Light-bringer" **as a comet**), from which derived the name of the Royal House of Lusignan - the Crusader Kings of Jerusalem.

The Fount of Melusine was said to be located deep within a thicket wood in Anjou, and Melusine was often depicted as a mermaid - as she is still beguilingly portrayed in an old painting at Count Dracula's Bran Castle in Romania.

The Tudor Queen, Elizabeth I, was by far the most in tune with ancient cultures and wood lore. She was even called the Faerie Queen and, before being formally crowned, she was installed by the people as their Queen of the Greenwood. This was an ancient ritual of the Shining Ones - the Elven Race of the Albigens.

Edward de Vere of Oxford was a friend and student of the Rosicrucian alchemist and Secret Service operative John Dee, and he worked closely with the statesman and philosopher Francis Bacon (later Viscount St Albans). Between them (along with others) they comprised the Royal Court Syndicate which was responsible for providing much of the material for the works of their playwright colleague, William Shakespeare.

As mentioned in connection with Melusine, fountains, springs and water in general were always associated with the Ring Lord female line. This stems from the very earliest times of the Anunnaki, whose founding mother (as explained in ancient Mesopotamian literature) was Tiâmat, the Sea-dragon. In later times, these queens were commonly represented as mermaids (mere maids), and were often called Ladies of the Lake.

# This was a style granted to Mary Magdalene when she had settled in Provence from AD 44.

While the male descendants of Mary Magdalene and Jesus became the noted Fisher Kings in Gaul, the female line retained its Dragon Queen status, in a quite separate dynasty, as the matriarchal Queens of Avallon in Burgundy. They were known as the House del Acqs (the House of the Waters), and among their number was the great 6th-century Queen Viviane, revered as the Lady of the Lake in Arthurian romance.

This heritage was so important to the Celtic Church that, when King Kenneth MacAlpin united the Scots and Picts in 844, his extant installation document made special mention of his descent from the Queens of Avallon.

The true significance of King Arthur was his immediate joint descent in both the male and female lines of the Albi-gens. His father was King Aedàn of Dalriada, the Pendragon of Britain in the year 559 and a descendant of the Wood Lord Beli Mawr. His mother was Ygerna del Acqs, the daughter of Queen Viviane, whose grandson (by Ygerna's sister, Viviane II) was the legendary Lancelot del Acqs.

Ygerna (sometimes called Igraine in the Grail tradition) was the High Queen of the Celtic kingdoms, and her daughter Morgaine (by her first husband, Gwyr Llew of Carlisle) was High Priestess of the Sisters of Avallon.

Over the years, there have been any number of speculations concerning the **historical Arthur**, but these are mainly fronted by tourist establishments endeavoring to claim the Arthurian heritage for their particular parts of England or Wales. The fact is, however, that (in line with the traditional accounts) there was only ever one High King of Britain called Arthur. There was only ever one Arthur born as the son of a Pendragon.

There was only ever one Arthur whose mother was Igraine of Avallon and whose grandmother was the recognized Lady of the Lake. There was only ever one Arthur with a son named Modred, and there was only ever one Arthur with a sister called Morgaine (or Morganna as some of the stories refer to her).

In this regard, the old annals of Scotland and Ireland, along with the records of the Celtic Church, are unanimous in identifying Arthur mac Aedàn of Dalriada. He was invested as Sovereign Commander and High King in the year 575 by the Druid, Merlin Emrys, and his primary seat was at Carlisle in the north of England, from where he controlled the military defense of the English-Scottish border country.

Historically, and quite outside the Christian propagandist mythology which surrounds the vampire character of Bram Stoker's famous novel, Dracula was Prince Vlad III of Wallachia, who is often referred to as Vlad Tepes.

Since the word tepes relates to "wooden poles", it is often thought that Vlad's descriptive nickname relates to his individual method of executing enemies of the State by impaling them upon wooden stakes. Hence, Vlad Tepes is sometimes said to mean "Vlad the Impaler". This, however, is completely untrue. He was called Tepes (as were many other Druidic elders before him) because, within the ancient Ring Lord culture of the Sidhé, he was an appointed Creachaire Portal Guardian. Vlad Tepes, a 15th-century Prince in Romania, founded the capital city of Bucharest. His popularized name, Dracula, means "Son of Dracul", and Dracul (or Dragon) was a style by which his father was known within the Grail fraternity of the Ordo Draconis (The Imperial Court of the Dragon) from 1431.

During this past century, ever since the 1897 novel, Dracula, was published, Vlad has become an archetype of the Church-promoted Gothic tradition. However, the establishment's real fear of Dracula was not his harsh treatment of enemies, as is so often cited, nor that he was a blood-sucking vampire in the Stoker tradition.

What they feared was his in-depth knowledge of alchemy and the fact that he was truly an operative Oupire - a venerated Overlord of the Rath, a Portal Guardian in the ancient Yulannu manner of the Ring Lords.

Those of you who have read Bloodline of the Holy Grail, or maybe even Genesis of the Grail Kings, will be familiar with the terracotta portrayal of the Sumerian goddess, Lilith, from around 2000 BC. In this depiction (as in those of other Anunnaki hierarchy) Lilith is seen to be holding the Rod and Ring of Divinely Measured Justice. The Rod was actually an instrument of measure, and in some portrayals it is very clearly marked in calculable units (like a modern ruler). By Babylonian times, it was referred to as the Rule, and the one who held the Rule was the Ruler - which is from where our governmental term derives.

The Ring (as mentioned at the beginning of this talk) was a symbol of wholeness, unity and eternity. It represented a continuance of Divine Justice - a justice that was measured by the Rod (or Rule). Hence, the Ring was the ultimate insignia of the Anunnaki Overlords - the enigmatic Oupires who were responsible for the establishment of municipal government and kingly practice - for they were the progenitors of civilization from about 4000 BC.

In view of this, it is of particular interest to note that Tolkien, when asked about the Middle Earth environment of his book, The Lord of the Rings, answered that he perceived its setting to relate to somewhere around 4000 BC.

From the earliest of European times, the Saxon god, **Wotan (or Odin, the equivalent of the Sumerian Anu)**, was said to have ruled the world with eight rings, having one more, the ninth ring (the One Ring), to govern the others.

During the mediaeval days of the Church's persecution of heretics and, indeed, through the Middle Ages and beyond, all manner of Grail-related subject matter fell prey to the wrath of the bishops and friars.

Buried along with kings and queens of the Dragon succession, these finely produced instruments were clearly ceremonial and would appear to have been used in ancient Star Fire and Fire-stone rituals, as described in Genesis of the Grail Kings.

The Fire-stone ritual (the ritual of the goddess Antu, or Barat An-na) was largely a levitation ceremony conducted with the monatomic, superconductive element of the Highward Fire-stone (the white powder of gold). Even in modern times, music has been used to perform levitational feats - notably in Tibet, where prohibitively large stone blocks have been lifted and positioned high in the mountains by using antigravitational sound frequencies.

The ritual involves nineteen musicians and, behind them, 200 monks, radiating outwards in lines (in groups of five) at five-degree intervals, facing towards a mountain cave.

The musicians use thirteen barrel-drums of variant sizes (weighing up to 150 kilograms apiece), suspended from wooden frames and directed towards a bowl-shaped cavity in which the required boulder is placed, between the musicians and the

cave. Also, there are six long trumpets positioned at intervals between the drummers. On command, the trumpets and drums begin, with the monks at the rear providing a baffle whilst chanting.

The time span before levitation of the stone occurs is four minutes and, in this manner, stones have been lifted some 400 meters, to be lowered into their necessary mountain temple positions.

The knights of this particular branch of the Templars (constituted by King Baldwin of Jerusalem in 1118) were called the Guardian Princes of the Royal Secret.

One of these musical sequences is the most famous of all: a tritone dubbed by the Church as "the Devil's interval". This is a direct extraction from the discovered harmonic scales of ancient Mesopotamian deities, which include the Enki scale, Enlil scale, Anu scale, Marduk scale, Kingu scale, Inanna scale and others.

No composer has done so much to preserve the legacy of Ring lore as Adrian's great-great-grandfather, Richard Wagner. His renowned 16-hour, four-part Nibelungen Ring Cycle - The Rhinegold, The Valkyrie, Siegfried and Götterdämmerung (Twilight of the Gods) - was largely drawn from Burgundian folklore, but derived ultimately from the very old Norse mythology of the Volsunga Saga.

By virtue of such Jewish writings, the Dominican wrath of the Spanish Inquisition (from about 1480) was largely directed against the Jews, especially those connected with Kabbalistic studies, and it was really as a direct result of this persecution that the witch-hunts began.

Prior to that, the Roman Inquisition had been more concerned with heterodox Christians: those heretics who were Christians of one sort or another (Arians, Nestorians, Nazarenes, or whatever), but were not members of the Roman Church, and whose culture revolved, to some extent, around traditions of magic and alchemy that were outside Church control. But, here were the Jews putting forward their own versions of the old lore - particularly those Jews in the Narbonne region of the Spanish Marches, where the House of David had once been given privileged rights of princely independence by Emperor Charlemagne.

And so, from the late 15th century, the Inquisition began a thorough process of "ethnic cleansing".

No one who was other than a full-blooded and obvious Catholic was safe. But, there had to be some new form of classification to pull all the prey into the ever-expanding net.

The Grand Inquisitor at the time was the brutal Tomâs de Torquemada, Senior Confessor to Ferdinand II and Queen Isabella of Spain. Under his direction, the answer was found and, very soon, the friars had set their sights upon "the most diabolical heathens who ever conspired to overthrow the Roman Church".

In 1484, two Dominicans, Heinrich Kramer and James Sprenger, published a book called The Hammer of Witches.

This evil but imaginative work gave full details of what was perceived to be the hideous new threat posed by all the practitioners of satanic magic. The book was so persuasive that, two years later, Pope Innocent VIII issued an official Bull to authorize the suppression of this blasphemous sect.

Up to that point, the cult known as Witchcraft (to the extent that it existed at all) had not really constituted a threat to anyone. It rested mainly in the continuation of pagan ritual and fertility rites by the peasant classes. In real terms, it was little more than the vestige of a primaeval belief in the divine power of natural forces, focused above all on Pan, the mischievous Arcadian god of the shepherds.

Pan was traditionally portrayed with the legs, ears and horns of a goat, but the creative Dominicans had other ideas about the pipe-playing Horned One, and they blackened his image so that he was seen to correspond to the Devil himself. However, since the Inquisitors were all men, it was determined that witchcraft must be a form of depravity linked to the insatiable wantonness of women!

The problem was that nobody really knew who these presumed witches were, and so a series of ludicrously tragic trials and tests was devised to root them out. In the midst of all of this, the harsh Puritan sect became politically allied to the Roman strategy, implementing its own witch-hunts in England and, later, in America.

Over a period of some 250 years, more than a million innocent men, women and children were murdered by the delegated authority of the witch-finders.

Sprites, Goblins and Gnomes.

**The definition of "sprite" is no more nor less than a "spirit person" -** one of the transcendental realm of the Sidhé. The original Sprites were the ancient Scythian ghost warriors who painted their bodies grey-blue to look like corpses when they entered the battlefield.

In Shakespeare's A Midsummer Night's Dream, the character Puck is described as a "sprite", and in traditional English wood lore Puck is identified with a certain Robin Goodfellow who was said to be a "goblin". His father was Herne the Hunter. Hence, Oberon and Herne are one and the same. The name Oberon (a variant of Albrey the Elf King, as we have seen) is itself a derivative of the Scythian Oupire (meaning "over") and Ron (meaning "reign").

Oberon, therefore, means "Over Reign", which is the same as High King or Pendragon.

The description of "goblin" stems immediately from the Germanic word kobelin, and the kobelins were said to be mine-workers or those who worked underground. In the context of the Ring culture, goblins were, in essence, attendants of the Oupire Portal Guardians of the Rath - the mound-dwellings of the Tepes gateways to the ancestral Netherworld - and they were just as human as the Oupires themselves.

Gnomes, like Goblins, were said to be the guardians of the underground treasures - which is why the word is today associated with banking, as in the so-called "Gnomes of Zurich". The word root is in the Greek equivalent of gno-, from which we get "gnosis" and "gnoble" ("noble"). The Gnomes were therefore, once again, of the noble race and were referred to as "the Wise Ones".

Their job was indeed one of guardianship: they were guardians of the gnosis (the knowledge) and the Sacred Bloodline of the Albi-gens. It is by way of the noble (or gnomic) distinction that the Fairy Race in general was referred to as the Gentry-particularly the Druidic caste of the Pict-sidhé (the Pixies) who were the ultimate custodians of law and culture. Their female counterparts were the Behn-sidhé (the Banshee), which, in old Irish, simply means "the Wise Women".

By way of redefining all the original names - Fairies, Elves, Pixies, Gnomes, Goblins, Sprites, or whatever - they diminished the problem by miniaturizing the nominal significance. In so doing, the transcendental race of the Sidhé was portrayed as minute little figures and moved into the realm of mythology. The fraudulent Donation of Constantine was then brought into play and, henceforth, only the Church could determine who was and was not a king!

If this strategy did not work sufficiently on its own, as was indeed the case in the Renaissance (a period of a more general awareness and enlightenment), then part two of the plan was brought into operation.

This was more specifically targeted at the key members of the Messianic strain: the ultimate Dragon succession of the Albigens - the dynastic Kings and Queens of the Sangréal and their senior Oupires. These people were real, and everyone knew that, so they could not be confined to the superficial realm of fantasy. They could, however, be portrayed as if (being of the Dragon blood) they were of a weird, half-human strain, beyond the Christian pale.

At best, they were perhaps mermaids and, at worst, they were vampires, but either way they were the evil, shape-shifting emissaries of Satan!

The fact that anyone believed such nonsense is difficult to comprehend in these more level-headed times. However, the myth is still operative and, to some extent, it is still working with a vengeance. It is even working on some whose apparent mission in life is to expose such propagandist dogma, but who - by way if its own cleverly contrived strategy - have actually fallen prey to it. In this regard, at this very moment there are some well-known, supposedly intelligent folk who should know better (David Icke), claiming that the British Royal Family, along with myself and others, are really hideous reptiles from another planet!

One of the most surprising things about the Scythian Ring Lords is that their preserved remains from thousands of years ago (discovered even as far north as Siberia) show their bodies substantially tattooed with ring-tailed lemurs. Lemurs, we are led to believe, are native to (and pretty much restricted to)

Madagascar and the Comoros Islands off Mozambique, but here they are, where we are told they never were, in northern Europe and the Black Sea regions!

It was the land of the mighty Warlords of the Dragon before they migrated and battled their way southwards in the ever-cooling climate of the last ice-age, they are now thoroughly identifiable from their preserved remains, which have been excavated at various sites from as far afield as Transylvania and Tibet. With their light-brown to red hair and pale eyes, the leather-clad men stood at least six foot six inches and upwards, while even the women were over six feet tall. Undoubtedly, these forebears of the Gaelic and Celtic High Kings were among the most awesome warriors of all history.

Of particular interest is the fact that the Anunnaki gods were as much a part of the Sidhé culture as they were of the Mesopotamian tradition. It was not for no reason that the settlement of Anu was hundreds of miles north of Sumer on the Caspian Sea. It was not for no reason that the ancient centre of Scythopolis (Sidhé-opolis), which the Syrians called Beth-Shean (the House of Power), was 800 miles away in Galilee. Indeed, it is now suspected that the Ubaid culture of southern Mesopotamia - the culture which introduced municipal structure from about 5000 BC - was actually the Uper-ad culture: that of the Scythian Overlords, the Upers or Oupires.

It is also reckoned that the subsequent culture of the region, phonetically called Sumerian (pronounced "Shumerian"), was actually Sidhé-murian ("Shee-murian"). In fact, the case for this is now considerable, since the early Ring Lords of Scythia (the Tuatha Dé Danann king-tribe) were actually called the Sumaire. And in the language of old Ireland - to where many of the caste migrated - the word sumaire means "dragon".

The fact is, however, that for all we have been told about our cultural identity being from the classical scholarship of Greece, or from the imperial majesty of Rome, these things are entirely untrue. Such establishments appeared very late in the day. The true sovereign heritage of Western culture - the culture from which derived all the so-called myth and legend which sits so comfortably within a collective race memory (no matter what the Church and academics might say in their attempts to sway us) - comes from one place alone. It comes from a place and time that might just as well be called Middle Earth as by any other name. It comes from the long-distant Realm of the Ring Lords. (New Earth woman & Tartaria movement are based on the Dragon linage as anenmies of the Church).

Early Sumeria and the Origins of Kingship.

One of the interesting items from the archives of the Dragon Court was the origin of the word 'kingship'. It derives from the very earliest of Sumerian culture wherein 'kingship' was identical with 'kinship' - and 'kin' means 'blood relative'. In its original form, 'kinship' was 'Kainship'.

And the first King of the Messianic Dragon succession was the biblical 'C (Kain)', head of the Sumerian House of Kish. "On recognizing this, one can immediately see the first anomaly in the tradition of the Genesis story, for the historical line from David to Jesus was not from Adam and Eve's son, Seth, at all. It was from Eve's son Cain, whose recorded successors (although given little space in the Old Testament) were the first great Kings (or Kains) of Mesopotamia and Egypt.

According to the Dragon tradition, the importance of Cain was that he was directly produced by Enki [Satan] and Ava [Eve], so his blood was three quarters Anuna. His half brothers Hevel and Satanael (better known as Abel and Seth) were less than half Anunas, being the offspring of Ateba and Ava (Adam and Eve).

We can now progress our story by considering the oldest Grant of Arms in sovereign history - the Grant of Arms which denoted the Messianic Dragon Bloodline for all time.

The Sumerians referred to this insignia as the Gra-al... From biblical history, we know it better as the 'Mark of Cain'." from Laurence Gardner

Sumerian and Babylonian King-Lists reveal the belief that "kingship" was "sent down" from "heaven" - decreed by the gods.

Many indigenous antic cultures followed the same tradition, including the Xiongnu, Scythians and Saka. Dynastic lists of pre-diluvial Sumerian kings were later re-catalogued in Babylon by Priest-Scribes.

The Egyptians also produced and monumentalized King-Lists, documenting the lineage of the Houses of their God-Kings in stone for all of Eternity. A name remembered was an afterlife assured.

The Dragon King was known as the King of Kings and his symbol, Draco, represented his succession through the Egyptian pharaohs, the Egyptian Therapeutae, the Qumran Essenes to the Merovingian kings of Europe.

"The kings of the early succession (who reigned in Sumer and Egypt before becoming kings of Israel) were anointed upon coronation with **the fat of the Dragon (the sacred crocodile**).

This noble beast was referred to in Egypt as the Messeh (from which derived the Hebrew verb 'to anoint'), and the kings of this dynastic succession were always referred to as 'Dragons', or 'Messiahs' (meaning 'Anointed Ones').

In times of battle, when the armies of different kingdoms were conjoined, an overall leader was chosen and he was called the 'Great Dragon' (the 'King of Kings') - or, as we better know the name in its old Celtic form, the

'Pendragon' (Planets with serpentine plasma tails were the origin of the Dragon & Serpent symbol of Ea's linage).

In pictorial representation, the Messianic Dragon was, in essence, a large-jawed serpent with four legs, very much like a crocodile or a monitor. This was the Sacred Messeh whose name was 'Draco.'

Draco was a divine emblem of the Egyptian pharaohs, a symbol of the Egyptian Therapeutate, of the Essenes of Qumran, and was the Bistea Neptunis (the sea serpent) of the descendant Merovingian Fisher-Kings in Europe." from Laurence Gardner

"Through the work of Sir Laurence Gardener we discover that Sumaire in the old Irish language means Dragon. He writes:

'It is also reckoned that the subsequent culture of the region, phonetically called Sumerian (pronounced 'Shumerian') was actually Sidhemurian (Shee-murian). This case is now considerable since the early Ring Lords of Scythia, the Tuatha De Danaan king tribe were actually called the 'Sumaire'.'

During the days of the Biblical Great Exodus, a group separated from Moses and went to the North. This group was the Tribe of Dann.

Millions went and settled in the European and Scandinavian areas. From there they spread out to other parts of the world, conquering the countries, spreading their Anuna seed and replacing the conquered people's traditions with their own serpent culture."

The Tribe of Dann and the Lost Tribe of Israel

The Canaanite territory of northern Israel was later occupied by the tribe of Dan, whose worship of Baal/Pan involved such fertility rites at Mount Hermon, also called Mount Sion.

Merovingians are the offspring of the tribe of Dan which intermarried with the Canaanite Tuatha De Danann, also known as the Dragon Lords of Anu because they were said to be the offspring of the fallen angels (Anuna).

When God dispersed the northern tribes for their wickedness, the tribe of Dan migrated to Greece, and later to France and the British Isles where they established pagan priesthoods and royal dynasties of the demonic

"The Tuatha De Danann (or Dragon Lords of Anu)... before settling in Ireland (from about 800 B.C.)... were the... Black Sea princes of Scythia (now Ukraine).

Like the original dynastic Pharaohs, they traced their descent from the great Pendragons of Mesopotamia; from them sprang the kingly lines of the Irish Bruithnigh and the Picts of Scotland's Caledonia. In Wales they founded the Royal House of Gwynedd, while in Cornwall in the southwest of England, they were the sacred gentry known as Pict-Sidhe. So, from a single caste of the original Blood Royal - whether known as the Sangréal, the Albi-gens or the Ring Lords - we discover many of the descriptive terms which sit at the very heart of popular folklore. For here, in this one noble race, we have the 'elves', 'fairies' and 'pixies' - not beguiling little folk, but distinguished Kings and Queens of the Dragon succession." Laurence Gardner, In the Realm of the Ring Lords

In 'The Psalter of Cashel' it states that:

'The Tuatha de Danaan' ruled in Ireland for about two centuries, and were highly skilled in architecture and other arts from their long residence in Greece.' The Tuatha de Danaan were the descendants of Danaus, the son of Belus, who went with his fifty daughters to Argos, the home of his ancestors Io.

In Irish legends the Tuatha de Danaan, who were considered to be demigods,... were said to have possessed a... Grail-like vessel... These teachers of wisdom... were the founders of the Druidic priesthood." Van Buren, The Sign of the Dove In Europe and the British Isles, the Dragon lineage intermarried with the royal families and became sovereigns.

## The Pendragons

The Druidic Dragon King or Pendragon, also called the King of Kings, was chosen by a Council of Elders to rule over all the kingdoms.

"Cymbeline was the 'Pendragon' of mainland Britain during Jesus's lifetime. The Pendragon, or 'Head Dragon of the Island'... was the King-of-Kings and 'Guardian of the Celtic Isle'.

The title was not dynastic; Pendragons were appointed from Celtic royal stock by a Druidic council of elders. The concept of the dragon in Celtic mythology emerged directly from the holy crocodile (the Messeh) of the ancient Egyptians. The Pharaohs were anointed with crocodile fat, and thereby attained the fortitude of the Messeh (Thus Messiah -

Anointed One). The image of the intrepid Messeh evolved to become the Dragon, which in turn became emblematic of mighty kingship.

The Celtic Kings in Britain were called 'dragons' in the ancient Messeh tradition as intrepid guardians. But there were many separate kingdoms in those days before England gained an overall monarch in Saxon times. It was therefore necessary to appoint a King-of-Kings - a High King to preside overall, and to lead combined armies from different tribal areas. The first Pendragon (Head Dragon/High King) was Cymbeline.

Columba... in 574, had crowned and anointed King Aedan mac Gabran of Dalriada (Celtic Pendragon and father of **King Arthur**) - the first British monarch to be installed by priestly ordination - and this greatly upset the Church of Rome."

## The Merovingians

The Druidic Pendragon was passed on to the Merovingian kings in **666 A.D**:

"The Celtic Pendragons were not father-to-son successors in a particular descent, but were chosen from various reigning dragon families and individually elected by a druidic council of elders to be the King of Kings.

The last Pendragon was Cadwaladr of Gwynedd, who died in A.D. 664. At around that time much of Britain fell to the Germanic influence of the invading Anglo-Saxon and Angle-land (England) was born as distinct from Scotland and Wales." "In 666, probably still in Ireland, Dagobert married Mathilde, a Celtic princess."

Baigent, Michael, Richard Leigh and Henry Lincoln, Holy Blood, Holy Grail.

"The Merovingian kings were noted sorcerers in the manner of the Samaritan Magi" (scientific knowledge) Laurence Gardner, Bloodline of the Holy Grail

The term "Merovingian" is said to derive from Merovee, King of the Franks from 447-458 A.D.

According to the legend, as explained in Bloodline of the Holy Grail, Merovee had two fathers, King Clodion and a strange "beast of the sea" (Ea's linage).

"Despite the carefully listed genealogies of his time, the heritage of Meroveus was strangely obscured in the monastic annals. Although the rightful son of Clodion, he was nonetheless said by the historian Priscus to have been sired by an arcane sea creature, the Bistea Neptunis (Neptune/Ea's seed).

The Sicambrian Franks, from whose female line the Merovingians emerged were associated with Grecian Arcadia before migrating to the Rhineland. As we have seen, they called themselves the Newmage - 'People of the New Covenant', just as the Essenes of Qumran had once been known.

The legend of King Merovee conceals the TRUE origins of the Merovingian race in remote antiquity. "Meroveus" derives from the French words "mer" meaning "sea" and "Vere" meaning "werewolf" or "dragon."

The book of Revelation informs us that the dragon is "the Devil, and Satan," (Adversary, Samael, Ea, Venus) hence the esoteric allusion to the Merovingians' progenitor, King Merovee, a king of France sired by a mysterious "beast of the sea," is a claim that the Merovingian dynasty has literal Satanic descent:

After the Merovingian dynasty was deposed by the Roman Church in 800 AD, their demonic bloodline was preserved by the "Imperial and Royal Dragon Court" which conspired to regain control of the Holy Roman Empire through infiltration of Church and State.

Their insignia was the dragon in the form of a circle and a red cross - the Rosy Cross of the Priori de Sion, the Knights Templar and the Rosicrucians.

The Merovingian dynasty still maintains its legitimacy and will one day openly assert the divine right of their nobility to rule the world as an angelic race of demigods, whose ancestors were the fallen angels.

King of Scots

Robert the Bruce was far more than an "early Scottish King." He was a high born Merovingian:

Below is a study of Haplogroups, the Mesopotamian marker T, and the Sumerian Marker J in the Jewish, Ashkenazi, Ethiopic, Arabic, and the Basque population which is high on O Rh negative blood type, as well as the relationship between RED/auburn HAIR colour and RH negative blood types.

T is the Mesopotamian marker. J is the Sumerian marker, and its offspring was J1 and J2. J2 Jewish and J1 Arabic descending from J. And J itself stems from JT which pinpoints to the ancient "Etruscans".

Todays Israelites, have a low percentage of Rh negative. Amongst Saudi Arabians the haplogroup J1 is highly represented. Only around 1/3rd of present Jews carries the J2 marker, so just like the Basque population could have once been 100 percent Rh negative with that number being lowered to around 1/3rd of that, so could the number of Jews carrying the Hebrew marker have been reduced through mixing with others in many of the countries their ancestors chose to migrate to. Another thing worth noting is that it seems that everywhere haplogroup R1b is high as in Scotland /Ireland, the percentage of people with haplogroup J is also high. And so is the percentage of people with red hair.

Haplogroup J is high in the island of Crete. Apparently the Y-DNA is around 34% haplogroup J2 in Crete. Sardinia is also a place where certain parts are extremely high in haplotype J. In Ethiopia where 18% are haplogroup J and 7 percent Rh negatives tower over the numbers of most other African nations.

Genetic studies on the Sumerians are limited and generally restricted to analysis of classical markers due to Iraq's modern political instability. It has been found that Y-DNA Haplogroup J2 originated in Northern Mesopotamia. The Sumerians were a non-Semitic people, and spoke a "language isolate, a number of linguists believed they could detect a substrate language beneath Sumerian. However, the archaeological record shows clear uninterrupted cultural continuity from the time of the Early Ubaid period (5300 - 4700 BC C-14) settlements in southern Mesopotamia. The Sumerian people who settled in the region, farmed the lands made fertile by silt deposited by the Tigris and the Euphrates rivers. There is no consensus among scholars on the origins of the Sumerians. The Ubaid pottery of southern Mesopotamia has been connected via Choga Mami Transitional ware to the pottery of the Samarra period culture (c. 5700 - 4900 BC C-14) in the north, who were the first to practice a primitive form of irrigation agriculture along the middle Tigris River and its tributaries. The connection is most clearly seen at Tell Awayli (Oueilli, Oueili) near Larsa, excavated by the French in the 1980s, where 8 levels yielded pre-Ubaid pottery resembling Samarran ware. Farming peoples spread down into southern Mesopotamia because they had developed a temple-centered social organization for mobilizing labor and technology for water control, enabling them to survive and prosper in a difficult environment.

The Basque and Catalonians have been present in the Pyrenees mountains about 7000 years, they are known as the first Europeans. Among the Basques are very low numbers of B & AB people. Current percentages of O blood type in people is 50%. Geneticist have taken a great interest in the Basque of far northern Spain because of their unusual language, which suggests they descend from some of the original settlers who arrived in southwestern Europe during and after the ice age. Though haplogroup K is relatively rare among the Basques today, mtDNA (mitochondrial DNA) extracted from prehistoric burials suggests that it was much more common in the past. In the remains excavated dating from 4000 and 5000 years ago (after Noah's flood) haplogroup K showed up at levels of 17 to 24%. A similar sample from a medieval Basque cemetery found that by around 1500 years ago the haplogroups had fallen to its present day level of about 4%. The Dark Ages of 550 AD could account for the near disappearance of haplogroup K (read King Arthur & the Dark Ages by Tess Clark) It could point to a near extinction event or females immigrating married into the Basque males. This exponential reverse trend indicates a strong likelihood that there was once a core group 100 percent mtDNA K. Analysis points to a group that around 5000 BC after Noahs flood, was 100 percent Rh negative and 100 percent identical to the ancient Hebrews on the female line.

The Ashkenazi: Ashkenaz was the 5th son of Japheth he settled around the Back Sea after the Flood. A few branches of haplogroup K such as K1a9, K2a2a and K1a1b1a, are specific to Jewish populations & specific to Ashkenazi Jews found at levels of 30%. Whose roots lie in central and eastern Europe, but are also found at low levels in the Jews of Near East, Africa as well as in the Sephardic Jews of medieval Spain. That indicates an origin of the K haplogroup branches in the Near East before 70 AD when the Roman destruction of Jerusalem scattered the Jews around the Mediterranean and beyond. About 1.7 million Ashkenazi living today, 20% of the population, share a single branch of the K haplogroup K1a1b1a. This diversity among the haplogroup of the Ashkenazi suggest that it arose in the Near East between 2000 and 3000 years ago (this matches the migrations caused by the Venus events), and everyone who shares it today could have shared a common ancestor as recently as 700 years ago. A similar pattern in two other branches, common among the Ashkenazi, K1a9 and K2a2, as well as the N1b branch of haplogroup N, has led researches to conclude that 40% of the Ashkenazi living today -about 3.4 million people- could descend from as few as 4 women who lived within the last 2000 years. Being that the Y-DNA marker of the ancient Hebrews (currently in around 1/3rd of Ashkenazis) and most of Arabs, was the Sumerian marker J.

As I mentioned above under genealogy of the gods, Abraham /Ibrum was actually born in Sumer, as stated in the old testament and Torah so the Hebrews would have this Y-chromosome marker. The Arabs consider Ishmael their forefather who was the son of Abraham and Hagar giving birth to him when Sarah (Sarai), Abraham's wife was told she was not able to have children. Sarah was also Abraham's half-sister, also Sumerian. There also appears to be a language connection

between the Basques and the ancient Sumerians. Dené—Caucasian is a proposed broad language family that includes the Sino-Tibetan, North Caucasian, Na-Dené, Yeniseian, Vasconic (including Basque) and Burushaski language families. A connection specifically between Na-Dené and Yeniseian was proposed by Edward Vajda in 2000, and has been met with some acceptance. Of course the original Hebrews and 12 tribes of Israel would also carry the Y-chromosome and O RhD negative blood. The Mediterranean isles, have a high percentage of both mtDNA K and Y-DNA J as in Cyprus and Crete. Haplogroup J has been found at a frequency of approximately 18% in Ethiopians, with a higher prevalence among the Amhara, where it has been found to exist at levels as high as 35%, of which about 94% (17% of total) is of the type J1, while 6% (1% of total) is of J2 type. On the other hand, 26% of the individuals sampled in the Arsi control portion of Moran et al. (2004) were found to belong to Haplogroup J.

And further genetic studies of Ethiopians conclude: Wilson et al. (2001), an autosomal DNA study based on cluster analysis that looked at a combined sample of Amhara and Oromo examining a single enzyme variant: drug metabolizing enzyme (DME) loci, found that 62% of Ethiopians fall into the same cluster of Ashkenazi Jews, Norwegians and Armenians based on that gene. Only 24% of Ethiopians cluster with Bantus and Afro-Caribbeans, 8% with Papua New Guineans, and 6% with Chinese. Both, the ancient Ethiopians and Indians were said to have white skin. Ethiopians are actually said to derive from India, but that was also more or less a theory at that time. What we see today is a result of those ancient tribes mixing with neighbours. The "Berber" marker is also very high amongst Ethiopians and said to originate there:

A composite look at most YDNA studies done so far reveals that, out of a total of 459 males sampled from Ethiopia, approximately 58% of Y-chromosome haplotypes were found to belong to Haplogroup E, of which 71% (41% of total) were characterized by one of its further downstream sub lineage known as E1b1b, while the remainder were mostly characterized by Haplogroup E1b1(x E1b1b,E1b1a), and to a lesser extent Haplogroup E2. With respect to E1b1b, some studies have found that it exists at its highest level among the Oromo, where it represented 62.8% of the haplotypes, while it was found at 35.4% among the Amhara, other studies however have found an almost equal representation of Haplogroup E1b1b at approximately 57% in both the Oromo and the Amhara. The haplogroup (as its predecessor E1b1) is thought to have originated in Ethiopia or elsewhere in the Horn of Africa. About one half of E1b1b found in Ethiopia is further characterized by E1b1b1a (M78), which arose later in north-eastern Africa and then back-migrated to eastern Africa. About the mtDNA:

A study of Černý et al. in 2008, indicates that many Ethiopians share specific maternal lineages with areas in Yemen and other parts of Northeast Africa. Most frequent haplotype in west coastal Yemen is 16126–16362, which is found not only in the Ethiopian highlands but also in Somalia, lower Egypt and at especially high frequency in the Nubians. The Tihama share some West Eurasian haplotypes with Africans, e.g. J and K with Ethiopians, Somali and Egyptians. Haplogroup T

Mesopotamian marker: approximately 4% and Haplogroup B at approximately 3%, make up the remainder of the Y-DNA Haplogroups found within Ethiopia. Everything points towards this region being home to an Rh negative society. Sardinia is also a place where certain parts are extremely high in haplotype J.

12 RANKS or Sacred Number of Hierarchy (equals the 12 Olympians):

Rank 60 AN/Anu: Uranus, Sky-Heaven god, Heavenly Father, Caelus (Heaven) Hephaestus (Heavenly Fire) & Helios (First Star seen), Ahura Mazda- Cult of Ankh or Anjou. Pratjapati, Sweta, Brahma. Later Enki/Saturn replaced Anu's main role. AN is Supreme ruler of all the gods. His symbol is the horned cap, the Asterisk \* (8 points-star) & the 4 pointed star with waves. The more horns on the cap denotes higher hierarchy. Heavenly Father or god who inhabits the heavens. Also depicted as a (golden) horned bull. Called "kishru" & in charge of the "Bull of Heaven" (planets & comets) which can be sent to earth to "avenge the gods" & cause death & destruction on Earth. Mesopotamian myths tell the story of how the Earth (Ki) and Uranus (An) were together and Earth was separated or "carried away" from heaven (URANUS) by Enlil at the beginning of time and Anu became "distant". This talks of the time when Earth orbited a red dwarf (Uranus) during the time of Eden/ Purple Dawn of Creation & was captured by Saturn (Enlil) from Uranus. Uranus sounds like UR+ANU (the Sumerian god AN-ANU). The Roman god IANU, fits the exact description of ANU. ANU's wife was ANTU and his consort wasNINMUL.

Anjou is the cult of AN (per royal genealogist Laurence Gardner). Also the cult of Ankh in Egypt.

He was Pratjapati & Sweta, then Brahma of the Hindus, Ahura Mazda of Zoroastrians. Hephaestus & Helios combined. Sumerian astronomers knew of the planets Uranus (Anshar/ An), Neptune (Ea) & Pluto (Gaga).

His wife was Damkina, daughter of Alalu (Ruler of the Igigi -on Mars? Later Marduk becomes the ruler. Sh-VA means 7 in Hebrew (Shiva is the Hindu god.)

Circa 1500 BC during Hammurabi's reign became ruler and Lord of Babylon known as Bel (meaning Lord) Belus who reign in Babel or Babili; location of the destroyed tower (ziggurat) of Babel. The Phoenicians are the Babylonians who worship Jezebel, daughter of Itho Baal, King of Tyre. Shown as a bearded man wearing on his tunic symbols of starsplanets he vanquished or rules over, holding a sceptre and ring (of kingship & dominion) and the Mushhushshu snakedragon sits by his side. (Marduk, Ashur, Enlil and Nabu all rode on a mushhushshu dragon (a charged planet with plasma discharges resembling dragons.) He re-wrote the original Enuma Elish and in the new version he killed the planet Tiamat (Neptune-Antu?), and is crowned as the supreme god, replacing Enlil and Ninurta in Babylon, as the main god & hero in the creation stories. Replaced Enlil as Saturn for his father Enki in the Enuma Elish.

Marduk became a Dictator & absorbed the name of all the other anunnaki gods c.1000 BC; called Bel in Babylon. Nabu-Nebo is the younger Bel (Lord for the Chaldeans) son of Marduk (the older Bel or Merodach), who reign in Babel (Babili). The babylonians called all demons (lesser god or ruler) Baal and Baalim (who were their Assyrian Enlilite enemy blood lines.)

Linage of the Anunas according to Sumerian tables:

The lineage of Enlil is represented by the Eagle and Enki's lineage is represented by Dragons or Serpents; symbols still found in todays royal bloodlines. The following charts are of known kings and rulers, but they also had many other children by the Anunas, some half, some 3/4 human, or demigods.) In Babylon the Enlilites (Enlil, Ishtar) were enemies of Enki & his linage, including Marduk & Nergal. The worshippers of Mitra in Iran, were in conflict with the worshippers of Mazda; and in Palestine the worshippers of El (Saturn) were in conflict with the worshippers of Jupiter and of Venus (Astarte) and so on....

In their place of origin the fifth ruler was ANSHAR. KISHAR was ANSHAR's wife.

AN.SHARGAL was the father of ANSHAR. ANSHAR's son was AN (ANU.)

ENSHAR's wife was NINSHAR.

AN's (Uranus) son by wife and half sister ANTU (Gaia, Earth) was Enlil.

Enlil's children with wife SUD (NINLIL) was ISHKUR.

Enlil's first born son by wife and half sister NINHURSAG (NIMMAH, NINHASAG) was NINURTA.

NINURTA's daughter with wife BAU GULA was NINSUN.

ISHKUR and his wife SHALA / Hebat had a son: NANNAR-SIN.

NANNAR-SIN with wife NINGAL (Nikkal) had twin children: UTU and INANA. And another daughter: ERESHKIGAL.

ERESHKIGAL's daughter by husband NERGAL (son of MARDUK \*see Enki's Linage) was LILITH. LILITH and Enki's child is KAIN.

UTU's wife was AYA.

INANA's child with Sargon (half human Canaanite, son of Ham) was LUGALBANDA (the first demigod king.) LUGALBANDA and his wife the goddess NINSUN (daughter of NINURTA and BAU GULA, of the line of Enlil with wife NINHURSHAG \*see next chart) son was GILGAMESH (Ninus, Nimrod B, king of Uruk for 126 years 2500-2275 BC, before Jupiter catastrophe.)

GILGAMESH's son was king UR.LUGAL.

LUGALBANDA's daughter was NIN.PUABI (NIN.E.Gula or NIN.Banda)

NIN.PUABI's children by husband MES.ANNE.PADA was MESKALAMDUG. NIN.PUABI died circa 2500 BC. Her remains were unearthed by archeologist Sir Leonard Woolley, who also found the inscriptions of Gilgamesh, a real king. NIN.SUN son's were king UR.NAMU and King DUMUZI (possibly fathered by his grandfather NINURTA, and known by the greek historians as Dionysus, the Egyptian Osiris; Tamuzz, protege of INANA. DUMUZI ruled Uruk -Ur, 100 years before Gilgamesh.

Amphael (possibly Gilgamesh) was enemy of Abraham, during 2300-2100 BC or prior and during the Jupiter events) Nimrod B ruled Shinar. GILGAMESH's kingdom of Uruk (Erech) was destroyed by the Bull of Heaven (possibly Jupiter or a comet accompanying the Jupiter's events).

Utnapishtim (Noah?) was the ruler of Shurupak before the great deluge.

AN's son by consort NINMUL was Enki.

Enki's first born son by wife DAMKINA was MARDUK, born in Nibiru. (Damkina, NINKI, was daughter of Alalu a.k.a. Shemhazai? Leader of the Igigi on Mars.)

MARDUK, also known as Bel, Moloch, RA of Egypt & Amun-RA (hidden Amun, when he left Egypt.) MARDUK's sons were SATU and ASAR, by wife SARPANIT (daughter of Enki by EDINNI, wife of Enkime- Enoch) they were the Egyptian Osiris (ASAR) and Seth (SATU) they both die before the great deluge.

ASAR's wife was ASTA (ISIS, daughter of Shemhazai, leader of the Igigi on Mars) when they arrive to Earth escaping the catastrophe on Mars caused by Uranus' instabilities, Shemhazai comes to Egypt to live with SATU (Typhon) and his wife NEBAT. (Interesting that Velikovsky & Sumerian texts mention that the Anunas left their planet due to Uranus causing catastrophes.)

MARDUK's other son was NABU also know as Nebo, Nabak, young Bel. NABU's wife was TESHMETUM.

(Saturn was attributed to Kurmabi, ALALU's son when it deposed Uranus. Kumarbi was AN's half brother according to the Hittite Story of Creation.)

Enki's sons by consort were: NERGAL (Err), GIBIL, NINGAL, NINGIZIDDA & GESTIANA. NERGAL's wife was ERESHKIGAL (goddess of the Underworld or Africa) their daughter was LILITH.

GIBIL was master metallurgist and maker of weapons.

NINGIZIDDA was known as Thoth of Egypt, Quetzalcoatl of the Americas, Khem, Kem- Anahuac of Mexico, and keeper of the knowledge of Medicine and Science, Building-Architecture & Calendars around the world.

Enki's children by 2 native females called Dawn and Dusk became some of the high priests, queens and kings that rule the Earth on behalf of Enki's linage. Dawn's child was ADAPA (equivalent to Adam.) Dusk's child was TITI (equivalent to Eve.) Enki takes Adapa and Titi to his kingdom in Eddini (equivalent to Eden) in Mesopotamia and "civilizes" or gives them knowledge. Enki's sister Ninhusarg assisted in the creation of the "black headed people" in the Mesopotamian creation epics, but I don't know if this means that she attempted to get pregnant by the native males at the very beginning. Enki 's son by Eve was KAIN (Cain) therefore Enki was the Serpent in the Garden of Eden.

Enki's son was IRID (Yared) by human Batanash.

Enki's son by 1/2 demi-goddess, LUMACH- Lamech's wife was NOAH.

According to the Dragon tradition (see Laurence Gardner's Bloodline of the Holy Grail and Genesis of Grail Kings) Enki's daughter -by his granddaughter the Anuna goddess LILITH- was Luluwa Lilith.

And the importance of Cain was that he was directly produced by Enki [Satan] and Ava [Eve], so his blood was three quarters Anuna. His half brothers Hevel and Satanael (better known as Abel and Seth) were less than half Anuna, being the offspring of Ateba and Ava (Adam and Eve.) Cain and LULUWA LILITH are the predecessors of bloodlines of the Jews and line of the Malkut (the Sovereign of Dragons.) This is the reason the female line is so important and probably the reason why the Roman-Catholic church (which according to the genealogies of the old testament & Laurence Gardner descends from the line of Essau) diminished or erased the importance of the "goddess" and women of this bloodline and attributed them with evil connotations: evil serpents, evil fairies, evil seductive mermaids, turned Mary Magdalene into a whore, called medicine women "witches" who were blamed for the pestilence, sickness or death brought on by the viruses and bacteria, radiation or poisonous gases that entered the atmosphere during the passing of comets (the link between witch

burning, pestilence & comets, please look at the dates of the plagues and the passing comets compiled in Noah Webster's book).

According to Laurence Gardner's book "In the Realm of the Ring Lords": When God dispersed the northern tribes for their wickedness (due to the Venus events in 1450 BC) the tribe of Dan migrated to Greece, and later to France and the British Isles where they established pagan priesthoods and royal dynasties of the demonic bloodline: "The Tuatha De Danann (or Dragon Lords of Anu) were the Black Sea princes of Scythia (now Ukraine), before settling in Ireland (from about 800 BC). Like the original dynastic Pharaohs, they traced their descent from the great Pendragons of Mesopotamia; from them sprang the kingly lines of the Irish Bruithnigh and the Picts of Scotland's Caledonia. In Wales they founded the Royal House of Gwynedd, while in Cornwall in the southwest of England, they were the sacred gentry known as Pict-Sidhe.

Sir Laurence Gardner and Nicholas de Vere were convinced that earthly kingship was created by this advanced race of the Anuna and that the world's mythologies are historical records. The information contained in the Legends of the Jews by Ginzberg, also contains information that strongly points to this possibility.

These beings "created the human race" by means of interbreeding and teaching scientific knowledge and also interbred with a portion of it, to create the RH Negative blood and kingly caste which until this day still maintains control over the world, through religions, states and monarchs. These are the creatures that have been symbolized or identified with shape shifting Dragons, Elves, Fairies, Gnomes, Leprechauns, Sprites, Nymphs, Pixies, Angels, Demons, Devils, Witches, Giants, Vampires, Mermaids, Werewolves, etc.

#### **MELUSINE:**

Descend from Enki and Lilith. Mermaid, Lady of the Ocean or Waters. Lived during the 8th century in 733 AD. The orthodox church (donation of Constantine implemented in 751 AD) considered them evil, vampiric, shapeshifting dragons, malevolent, fairies, elf queen. In Albany, Scotland and Northumberland the story is that a beautiful woman singing by a fountain called Prèssyne, married to King Elynas. They had 3 daughters of which the eldest was Mélusine, whose punishment was to have her legs transform into a serpent's tail every Saturday. Mélusine moved to France and married Raymond, son of the Earl of Forez. She built Chateau Lusignan. She "shape shifted into a dragon and flew away" (a plasma formation was seen in the skies resembling a dragon during her life or death & this story was created.) She was of the line of Ereshkigal, descendant of Enlil, sister of Inana and mother of Lilith, Tiamat, Bashemath down to Prèssyne. She was the Lady of the Lake. Elynas King of Albha (North Argyl) married Pictish Queen Bruithina (the Prèssyne of the leyend.)

According to Ginzbergs's Legends of the Jews the 10 Patriarchs of the old testament and other descendants were:

Adam-Seth-Enosh-Kenan-Mahalalel-Jared-Enoch-Methuselah-Lamech-Noah.

Eve and Samael (Satan or Enki) had son: Cain.

Adam with partner Lilith (called a female spirit) gave birth to demons (goddess- with hybrid human Adam) of various kinds. The first born was Agrimus, who was endowed with peculiar powers or gifts.

Adam with partner Eve had two sons: Haba (Abel) and Seth. Seth was the ancestor of the Messiah and he did not need circumcision (just like the Anuna). Men resembled centaurs and apes (mutations due to radiation happen to humans, animals and plants after Uranus' nova.) When paradise was lost for Adam (Uranus event) the Shekinah remained behind enthroned above a cherub (seen as a star/Uranus?) under the tree of life (the red dwarf Uranus or the red plasma sheath, could not be fully seen as it was either partially covered by Saturn or became distant and weaker in radiance under the heliosphere's influence). Adam and his descendants used to sit under the splendour of the Shekinah who was 64,000 times more radiant than the splendour of the (current) Sun. This light's brightness drives away disease (similar to infrared light.) It was during the time of Enosh that men began to gather gold, silver, precious gems and pearls from the Earth (brought about with the incoming debris by Uranus' nova.) \*see "It rains solid diamonds on Uranus and Neptune":

The use of "magic arts" (scientific astronomical knowledge) of the heavenly bodies was taught by the angels Uzza and Azzazael. It was during this time and that of Jared (circa 700 years before Noah's Flood) that 200 angels (Igigi probably from Mars?) descended on Mount Hermon (were Baalbek, Lebanon is now located.) The angels took women for wives (they were compatible) and had giants with them. There was a famine during Lamech's time, the second of ten great famines.

Seth's son was Enosh. During Enosh's generation 'God' caused the sea to transgress its bounds and a portion of the Earth was flooded (Uranus went nova, and was dethroned by Saturn?) The removal from paradise occurred, the mountains became rocks and the bodies of man began to decay (the light of the Shekina which inhibited the growth of viruses and bacteria disappeared.) Men lost its likeness and image to god (lost its gigantic stature, that resemble the royal Lords, just like Adam, Seth and Enosh did.) They were still giant compared to our current size, but lost a big portion of it. Most dinosaur-size mammals, like the beast called behemoth and other huge air and sea creatures perished due to flood and change in atmospheric conditions and their bones instantly fossilized due to the electrical discharges and other phenomena. The wooly

mammoth, saber tooth tiger and others alike, survived until the catastrophes of the Venus events, circa 1450 BC; there are dinosaur pictographs next to humans & skeletons of humans are found next to the remains of these beasts.

Enoch was the seventh generation and during his lifetime all the patriarchs except Lamech, were swallowed & killed by an earthquake, famine or floods. Lamech was killed by Cain. Lamech and wife Adah had two sons: Jabal and Jubal. Lamech and wife Zilah had a son Tubal-Cain and a daughter Naamah. Tubal-Cain was keeper of the knowledge of metallurgy of iron and copper & forging weapons for war. In Iberia, they say that Tubal Cain founded Terragona a few centuries after Noah's Flood of c. 4000 BC.

Semhazai with a mortal-Earthling woman had two sons, Himwa and Hiyya.

Naamah with the angel Shamdom had a son called Asmodeus (a devil -son of Enki?) Naamah was a Cainite (a descendant of Cain.)

The Cainite women with various angels (giants or Igigi?) birthed the Emim/ Rephaim/ Gibborim/ Zamzummim/ Anakim/ Ivvim.

Seth's family resided on the mountains by Paradise. Cain resided in Damascus, where Abel was killed. After Mathusael and Adams death, Seth and Cain's families intermarried and birthed the Nephilim, claiming noble descent from Seth.

When Methuselah died, the laws of nature changed! The Sun rose in the West and set in the East (due to Earth changing current sheath within the Birkeland current of the Heliosphere? The Deluge began. The angel Raziel gave Noah the Holy Book called "Torah" where celestial or Astronomical knowledge and Science was recorded and had been previously given to Adam, it also contain instructions to build a waterproof ark. The book had been hidden in a cave until it was revealed to Enoch. He studied and learned the information and hid the book again. The book was made of sapphires and it was enclosed in a golden casket (could this be the ark of the covenant the Templars where digging & looking after, under the Temple of Salomon??) It served as a time-piece to distinguish night from day and Noah gave it to Shem and Shem gave it to Abraham and Abraham gave it to Jacob, Jacob to Levi, Levi to Moses, Moses to Joshua and Joshua finally gave it to Solomon. This is probably the birth right or "blessing" that Essau gave his younger brother Jacob in exchange for a pot of lentils due to famine & other catastrophes during the Jupiter event of 2,100 BC and the reason discord has existed for thousands of years until the present.

When the Deluge began the sun was darkened, there were earthquakes, lightning bolts and thunder. The rain was boiling. Noah's wife Naamah, was the daughter of Enosh and their three sons and wives survived after the flood. The water from above came in though the space left when "god removed 2 stars from the Pleiades and gave them to the Bear constellation" (due to axis or orbit changing). Other changes to the celestial planets (spheres) happened during the YEAR of the flood such as the Sun and Moon shed no light. The ark was illuminated by a precious stone that shone with light, brighter during the night. The flood lasted a whole year (a full sun year of 12 months and 11 days.) During 150 days the

water covered most of the Earth, 15 ells above ground. Cain perished. While Shem received the special garment called tallit (some kind of armor or protective gear) Japheth got a simple toga. Noah explained that the Shekinah would only dwell in the First Temple built by Solomon, a descendant from first born son Shem and not on the second temple built by Cyrus a descendant from Japheth.

In the year 1569 after the creation of the world, Noah divided the earth by lot among his three sons, in the presence of an angel. The south fell to the lot of Ham, and the north became the inheritance of Japheth. The land of Ham is hot, Japheth's cold, but Shem's is neither hot nor cold, its temperature is hot and cold mixed. Shem's territory contained the Holy of Holies in the Temple, Mount Sinai and Mount Zion. 104 lands and 99 islands were divided among 72 nations, each with its language: Note that the lands of Jacob were given provisionally to Canaan. Raphael gave Noah the art of healing with plants. When Abraham lived, earthquakes and fire (electric discharges from Jupiter/ Zeus' thunderbolts) killed thousands. It was also not until Abraham's time (circa 2,100 BC -Jupiter events) that men did not outwardly age. When Abraham died, the lord sent the angel Michael (planet Jupiter) and when he saw Abraham, he cried and his tears became precious stones! (either fallout from Jupiter or Saturn's nova carried by a comet's tail, \*see scientific findings that diamonds rain inside Uranus and Neptune's atmospheres) when the angel took Abraham's body up to heaven in a cherubim's chariot (comet/plasma discharge), Abraham saw evil on Earth and asked Michael to send fire to consume them (fire bolts and electric discharges from Jupiter most likely, although there were also comets, meteor showers and volcanoes affecting Earth) so he did, and also said, let the earth open up and swallow them alive (the Jordan rift open up and the dead sea was created.)

God also sent "Death" the night Abraham was supposed to die and Death revealed 2 heads (comets with comet tails) one had the face of a serpent, the other head was like a sword. All the servants of Abraham looking at the fierce mien (comets) died -of radiation? The Jews proclaimed a day of prayer and fasting to supplicate god to turn aside the SWORD (plasma formations in the shape of a lance or sword) suspended above them.

The exiled Israelites were followers of Kronos -Saturn -Typhoon the Canaanite Baal of the ancient Israelites. "The star of your gods (Kvav Elohaicem) Chiun is Saturn. In Persian kevan-kaivar-kaiwan is Saturn. For the Scythian tribe, Mando is Saturn or Manasseh. For Egyptians Kronos was Thoth. For Phoenicians Kronos was ISRAEL or IL and his son was Yehud-Jehud. In Akkadian kaimanu -meaning constant and enduring- is Saturn (worshipers of Enki & his bloodline.)

This division of the earth took place toward the end of the life of Peleg, the name given to him by his father Eber, who, being a prophet, knew that the division of the earth (cataclysms causing geological changes) would take place in the time of his son's lifetime. The brother of Peleg was called Joktan, because the duration of the life span of man was shortened in his time (probably during the Tower of Babel and Mercury events) after Saturn's nova and exiting its orbit, first being captured by Jupiter and then moving towards orbiting a new star, the Sun. New species and mutations of animals and plants, due to atmospheric composition, lower oxygen levels, Earth's axis, orbit and place in the Universe constantly changing for

thousands of years. How confusing & frightening it has been for the inhabitants of Earth & solar system. I wonder if the Sun had other planets besides Jupiter, when the triple star system was captured by the Sun.

The linages below are according to the Bible.

Continuing from the patriarchs mention above, Noah had 3 sons: Shem, Ham and Japheth.

From the line of Shem descend the Semites, which according to Velikovsky's research found in "Peoples of the Sea", are the dolichocephalic or elongated skulls, except for the Perest. The Pereset are the round skull Persians.

Shem had 5 sons who rule Mesopotamia after the Deluge:

- 1. Elam: ruler of Persians, known as the Pereset
- 2. Ashur: ruler of Assyrians
- 3. Arphaxad: ruler of Chaldeans
- 4. Aram: ruler of Syrians
- 5. Laud: ruler of Lydians (Amalek, Pahris, Djordjan, Tasm)

From Arphaxad of the Chaldeans descends his son Kainan, and from Kainan's daughter On, her son Nahor, father of Terah. He was from Ur (Mesopotamia) and was a high priest of Marduk (house of Ram.)

Terah re built a tower/observatory to observe Jupiter (probably the same tower of Babel or Babili, which was partially destroyed about 200 years after Saturn's Deluge during the Mercury events) Jupiter caused the catastrophes in 2040 BC (blamed on the Elohim.) King Shulgi rules Ur.

Thera's sons are Haran, Nahor and Abram (Abraham.)

Haran's sons are Iscah and Lot. Lot has intercourse with his two daughters and the descendants are Moab (Moabites) and Ammon (Ammonites.)

Nahor's son with wife Micah was Bethuel. Their children are Laban and Rebekah. Laban's daughters are Leah and Rachel. Abram (Abraham) has two wives. Hagar and Sara. His son with Hagar is Ishmael (Arabs, Iran) Ishmael daughter is Mahalet. Abram's son with Sara was Isaac. Isaac's sons with Rebekah: his first born Essau and JACOB. Essau's children with Mahaleth were the Amalek, Ephrain, Persians) who become the founders of Rome, Germany, Sparta, ruler Alexander the Great, Russia, China, Venice. JACOB had children by 4 women: Leah, Balun (a servant), Zipah (a servant) and Rachel. The ones in caps are the 12 tribes of ISRAEL, known as the ARYANS (Aryan means Noble peoples.) The children of Jacob and Leah are REUBEN, JUDAH, SIMEON, ISSACHAR, ZEBULIN Dinah. The children of Jacob and Baluh are DAN

and NAPTALI. Jacob's children by Zipah are GAD and ASHER. Jacob's children by Rachel are Joseph and BENJAMIN. Joseph's sons are EPHRAIM (America) and MANASSEH (Magi.)

JUDAH's Kings and approximate reigns as follows: David 1048 BC, Solomon 1015 BC, Rehoboam 975 BC, Abijah 957 BC, Asa, 911 BC, Jehoshaphat 873 BC Jehoram 849 BC, Ahaziah 840 BC, Queen Athaliah 842 BC, Joash 837 BC, Amaziah, 8?? BC, Uzziah 811 BC, Jothan 759 BC, Ahaz 742 BC, Hezekiah 726 BC, Manasseh 697 BC, Amon 642 BC, Josiah 640 BC, Jehoahaz 6?? BC, Jehoiakim 609 BC, Jechonia 596 BC, Zedekiah, Sheatiel, Pedena, Zerubabel.

The Pereset are the round skull Persians as per Velikovsky's "Peoples of the Sea".

According to Velikovsky (\*see Velikovsky Archive) some of the lost tribes migrated to Russia's Scythian plain during the 7th and 6th century BC due to the catastrophes caused by Venus and Mars.

Other tribes went to Iran (Turkestan or Turan) and the Colchis in the Southeastern coast of the Black Sea. The Scythian in Ukraine area, worship EL or Saturn. The Khazar dominated south and eastern Russia since the 3rd century AD, specially the 10th and 11th century AD, occupying as far as Bulgaria and Ukraine.

The Khazars followed the Hebrew religion of Yahweh, spoke Hebrew and the names of their rulers were Hebrew. \*see Velikovsky's essays in Archive, under "Lost Tribes of Israel".

The Ashkenazi went from the Back Sea to Germany, Poland, Romania and Central Europe. Laurence Gardner states the Scythian tribe migrate & separate becoming the Scotts, Britts, Celts, Franks. During Jesus' time, when the Romans expelled the Tribe of Judah (incl. Levi) they went to Spain, and became the Sephardim or Sephardic Jews of Languedoc-Septimania and Medieval Spain, transported with help of the Phoenicians to Catalonia now Spain and Southern France. The Jewish Kingdom of Septimania formed in Languedoc under Guilhelm de Guellone, a Merovingian Scion. Hermit of San Michael. The Arthurian Legend began in Catalonia & Southern France. Later migrations spread along the Pyrenees and into Catalonia. ESAU/Essau (EDOM) was the twin brother of Jacob (12 tribes of Israel.) They become adversaries (most likely due to starvation during the Jupiter catastrophes) because Essau sells his birth right to Jacob in exchange for food (bowl of lentils.) His birth right or "blessing" was most likely scientific/astronomical knowledge and metallurgy/weapon technology, passed down since Adam to Noah to Abraham & down to him. There is a prophecy that in the end times there will be a war between their descendants.

Essau's descendants are predominantly Germany. Due to the dispersion of the tribes of Israel, Joseph's descendants became the English speaking nations. Germans worship Esau/ ODIN, and Hitler was an alleged descendant of Odin (Enlil) also known as Koz, god of the Idumeans of Middle East. The Danish Kings descend from Odin/Elil. The Swedish & Norwegian Kings descend from Frey (UTU, probably Apollo)

The 12 tribes of Israel descend from Jacob's 12 sons. At the time of death of King Solomon, circa 1000 BC, the tribes divide into 2 kingdoms:

The kingdom of Israel at the north was formed by 9 tribes except the tribes of Judah (Yehuda) Benjamin & Simeon (Levi among them.)

The kingdom of Judah (Yehuda) Benjamin & Simeon ruled under King David & called themselves kingdom of Judah. (\*see hebrewnations.com)

The 9 tribes of Israel went on exile by Assyria, becoming the lost tribes of Israel.

The Romans expelled the remaining tribes of the south of Judah at the time of Jesus Christ, over 2000 years ago. Some were transported with the help of the Phoenicians to Spain and South of France & were called Sephardim/ Sephardic Jews who became wealthy. The ones established in Central Europe: Prussia, Hungary, Romania, Poland & Caucasus mountains where called Ashkenazi. Both Sephardic and Ashkenazi Jews descend mainly from the tribes of Yehuda (Judah), with the exception of the Cohanim (Cohen) priest line, who descend from Levi.

Son's of Jacob (Israelite tribes) in order of birth, by Leah: Reuben, Simeon, Levi and Judah; by Bilha: Dan and Naphtali; by Zilpha: Gad and Asher; by Leah: Issachar and Zebulin; by Rachel: Joseph and Benjamin. Joseph's son by Osnat: Ephraim and Manasseh.

From the line of Ham, descend the Hamites (black people too.) Kush/Kish/Cush, naming the city of Kish; Ethiopia and Egypt. Ham is know as Nimrod in the Bible. Ham's youngest is the "cursed" Canaan (Canaanites), and Canaan's second's son was the ruler of the HITTITES. According to Laurence Gardner's "Jesus Messiah and Merovingian Scion" in 1099 the Canaanites (the German Houses of Hanover & Saxe- Coburg and Gotha and the church of Rome) are the enemies of the Hebrews including the House of Stewarts of Scotland, who are of the linage of David (represented by a white unicorn) down through Jesus & Mary Magdalene.

Cush subdued the tribe of Japheth (third son of Noah) because Cush's father Ham had stolen the "Garments" or Weapons given to Adam after the catastrophe (caused by Uranus a.k.a. "expulsion from the Garden of Eden") and then given to Noah before the Deluge of circa 4000 BC.

Noah's third son is Japheth. Japheth's 5th son Tubal-Cain, colonized the Iberic Peninsula and founded Tarragona, after Cush fights him, about 142 years after Deluge, according to the Basque.

Abstract: "The emerging genetic picture is based largely on two studies, one published two years ago and the other this month, that together show that the men and women who founded the Jewish communities had surprisingly different genetic histories.... A new study now shows that the women in nine Jewish communities from Georgia, the former Soviet republic, to Morocco have vastly different genetic histories from the men.... The women's identities, however, are a mystery, because, unlike the case with the men, their genetic signatures are not related to one another or to those of present-day Middle Eastern populations.... The new study, by Dr. David Goldstein, Dr. Mark Thomas and Dr. Neil Bradman of University College in London and other colleagues, appears in The American Journal of Human Genetics this month.... His [Goldstein's] own speculation, he said, is that most Jewish communities were formed by unions between Jewish men and local women, though he notes that the women's origins cannot be genetically determined.... Like the other Jewish communities in the study, the **Ashkenazic** community of Northern and Central Europe, from which most American Jews are descended, shows less diversity than expected in its mitochondrial DNA, perhaps reflecting the maternal definition of Jewishness. But unlike the other Jewish populations, it does not show signs of having had very few female founders. It is possible, Dr. Goldstein said, that the **Ashkenazic community** is a mosaic of separate populations formed the same way as the others.... 'The authors are correct in saying the historical origins of most Jewish communities are unknown,' Dr. [Shaye] Cohen [of Harvard University] said. 'Not only the little ones like in India, but even the mainstream Ashkenazic culture from which most

American Jews descend.'.... If the founding mothers of most Jewish communities were local, that could explain why Jews in each country tend to resemble their host community physically while the origins of their Jewish founding fathers may explain the aspects the communities have in common, Dr. Cohen said...

Ancestry of mtDNA in Ashkenazi Jewry

"Both the extent and location of the maternal ancestral deme from which the Ashkenazi Jewry arose remain obscure. Here, using complete sequences of the maternally inherited mitochondrial DNA (mtDNA), we show that close to one-half of Ashkenazi Jews, estimated at 8,000,000 people, can be traced back to only 4 women carrying distinct mtDNAs that are virtually absent in other populations, with the important exception of low frequencies among non-Ashkenazi Jews. We conclude that four founding mtDNAs, likely of Near Eastern ancestry, underwent major expansion(s) in Europe within the past millennium."

Abstract: "...about 40% of the total Ashkenazi population are descended from just four women, a genetic study indicates. Those women apparently lived somewhere in Europe within the last 2,000 years, but not necessarily in the same place or even the same century, said lead author Dr. Doron Behar of the Rambam Medical Center in Haifa, Israel. ... Each woman left a genetic signature that shows up in their descendants today, he and colleagues say in a report published online by the American Journal of Human Genetics. Together, their four signatures appear in about 40% of Ashkenazi Jews, while being virtually absent in non-Jews and found only rarely in Jews of non-Ashkenazi origin, the researchers said. Ashkenazi Jews are a group with mainly central and eastern European ancestry. Ultimately, though, they can be traced back to Jews who migrated from Israel to Italy in the first and second centuries, Behar said. Eventually this group moved to Eastern Europe in the 12th and 13th centuries and expanded greatly, reaching about 10 million just before World War II, he said. The study involved mitochondrial DNA, called mtDNA, which is passed only through the mother. ... Mike Hammer, who does similar research at the University of Arizona, said he found the work tracing back to just four ancestors "quite plausible... I think they've done a really good job of tackling this question." But he said it's not clear the women lived in Europe. "They may have existed in the Near East," Hammer said. "We don't know exactly where the four women were, but their descendants left a legacy in the population today, whereas ... other women's descendants did not." Behar said the four women he referred to did inherit their genetic signatures from female ancestors who lived in the Near East. But he said he preferred to focus on these later European descendants because they were at the root of the Ashkenazi population explosion."

The original Europeans who carried the rhesus negative blood factor were probably the original Europeans who painted the comic strips and other art in the caves of southern France and northern Spain which includes the Chauvet-Pont-d' Arc cave and the Lascaux cave paintings found in the Pyrennes.

The rhesus negative blood factor is a recessive phenotype while the O rhesus positive factor is a dominant phenotype. Black wavy hair, brown eyes, copper to brown tanned oily skin are dominant phenotypes which the men who drew these cave paintings most likely possessed. The women most likely possessed dominant features as well but probably had hazel eyes and slightly lighter skin which may have been less oily. These women were probably the carriers of the O positive blood factor.

# Ashkenazi Jews descend from 350 people, study finds

'Bottleneck' dates back 600 to 800 years, genome analysis shows; researcher says among population 'everyone is a 30th cousin'

A New study concludes that all Ashkenazi Jews can trace their ancestry to a "bottleneck" of just 350 individuals, dating back to between 600 and 800 years ago.

The study, published in the Nature Communications journal Tuesday, was authored by Shai Carmi, a computer science professor at Columbia University, and more than 20 medical researchers from Yale, Columbia, Yeshiva University's Albert Einstein College of Medicine, Memorial Sloan-Kettering Cancer Center, Hebrew University of Jerusalem and other institutions.

Researchers analyzed the genomes of 128 Ashkenazi Jews and compared them to those of non-Jewish Europeans in order to determine which genetic markers are unique to Ashkenazi Jews. They found that the Ashkenazi Jews' genetic similarities were so acute that one of the study's researchers, Columbia professor Itsik Pe'er, told the Live Science website that among Ashkenazi Jews, "everyone is a 30th cousin." The findings will enable researchers to catalog nearly all of the genetic variations from the founding population, the study's authors said. Such thorough genetic cataloging could help clinicians interpret individual genetic mutations, improve disease mapping and provide insight into the histories of Middle Eastern and European populations, the study said.

The catalog of complete Ashkenazi Jewish genomes should help identify the disease-causing mutations that the progenitors of Ashkenazi Jewry they passed on. Until now, data has only been available for a small subset of common Ashkenazi DNA markers – about one in every 3,000 letters

"Our study is the first full DNA sequence dataset available for Ashkenazi Jewish genomes," said Itzik Pe'er, an Israeli computer scientist at Columbia University, who led the study. "With this comprehensive catalog of mutations present in the Ashkenazi Jewish population, we will be able to more effectively map disease genes onto the genome and thus gain a better understanding of common disorders. We see this study serving as a vehicle for personalized medicine and a model for researchers working with other populations."

Ashkenazi Jews are known to have origins in the Levant, which Israel is smack dab in the middle of. But exactly who "European" Ashkenazi Jews are has long been debated. An analysis of the gene database shows that the original Ashkenazi Jews were about half European and half Middle Eastern. They lived in the medieval era, about 600 to 800 years ago, according to the analysis – and numbered just 350 or so people.

"Our analysis shows that Ashkenazi Jewish medieval founders were ethnically admixed, with origins in Europe and in the Middle East, roughly in equal parts," said Shai Carmi, a post-doctoral scientist who works with Pe'er and conducted the analysis. "[The] data are more comprehensive than what was previously available, and we believe the data settle the dispute regarding European and Middle Eastern ancestry in Ashkenazi Jews."

The analysis also suggested that today's Europeans are descended primarily from migrants from the Middle East after the last ice age, about 20,000 years ago, not from the first humans to arrive to the continent about 40,000 years ago. The researchers are now looking into where the Middle Eastern and European Jews first met and who their closest descendants are today.

Because the Ashkenazi community started out so small, and remained genetically isolated, it developed a higher load of disease-causing mutations. Even today, Ashkenazi Jews are known to be at higher risk for many diseases, including breast and ovarian cancer and Tay-Sach's disease. But many potentially disease-causing Ashkenazi mutations remain unknown. To address this problem, Pe'er and a team of researchers at the Ashkenazi Genome Consortium (TAGC) did high-depth sequencing of the Ashkenazi genomes. Finding that the genomes had almost 50 percent more mutations than did European samples on average, they compiled a comprehensive catalog of genetic mutations found among Ashkenazi Jews.

The catalog is already proving useful for carrier testing, the genetic analyses prospective parents undergo to see what diseases they risk passing onto future children. They are also working to sequence some 500 more Ashkenazi genomes to further strengthen the catalog.

"TAGC advances the goal of bringing personal genomics to the clinic, as it tells the physician whether a mutation in a patient's genome is shared by healthy individuals, and can alleviate

concerns that it is causing disease," said Lencz. "Without our work, a patient's genome sequence is much harder to interpret, and more prone to create false alarms. We have eliminated two thirds of these false alarms."

By revealing genetic information unique to Ashkenazi Jews, the catalog should also allow the pinpointing of genes behind more of the diseases that plague the population. The researchers are already studying specific Ashkenazi diseases to this end, including schizophrenia, Parkinson's disease, Crohn's disease, and cancer, as well as other traits, such as longevity. The researchers expect many of these medical insights to be relevant to the general population as well.
